

# Minutes of Meeting of the Policing Authority

### 1. Meeting of Members in Private

The Authority exercised its option to have a meeting in private and a confidential minute was provided by the Chairperson to the Secretary.

#### 2. Chairperson's Opening Remarks

The meeting agenda was approved as drafted. Members noted two pieces of correspondence received from GSOC in relation to the fatal shooting of Mr George Nkencho and a public interest investigation conducted into the circumstances of the arrest and detention of Mr. John O'Driscoll in the context of his death a number of days after release. Members acknowledged the importance of continuing to receive information of this nature, in the context of the Authority's oversight of the Garda Síochána.

The Chairperson advised that the appointment, by government, of an additional Authority member was anticipated in July and it was hoped that the appointee would be in a position to attend the 27 July meeting.

# 3. Consent Agenda Items

#### 3.1. Minutes of Meeting and Matters Arising

The minutes of the meeting held on 24/25 May were approved and cleared for publication.

# 3.2. Policing Authority and Garda Síochána Actions Logs

The Log of Actions was noted and proposals to close specified actions were approved. Members noted a response received from the Garda Síochána in relation to the feasibility of expunging expired juvenile detention records from PULSE and the supporting rationale for the retention of such information.

#### 4. Chief Executive's Report

The Chief Executive's report was taken as read and further updates were provided to Members on a number of matters in the context of the report, including in relation to:

- Engagement with the Department of Justice and the Public Appointments Service on the arrangements for conducting a selection competition for appointment to the rank of Deputy Commissioner. The Chairperson apprised Members of his discussions with the Commissioner on the matter. Members discussed the likely timeframes for the competition, having regard to the existing legislative framework and the Authority's current role in respect of Garda appointments. The Chief Executive advised that once government approval was received, a draft Candidate Information Booklet would be brought for Members' consideration.
- Attendance at a symposium in Toronto on the relationship between oversight and police
  governance, hosted by the Munk School of Global Affairs and Public Policy and prompted by the
  recent creation of the Inspector General of Policing of Ontario. The Chief Executive advised that the
  role and function of the future Policing and Community Safety Authority with inspection functions
  held by a public oversight body attracted significant interest by those attending the symposium.
- Attendance at the European conference on Law Enforcement and Public Health in Umeå, Sweden.
   Members were apprised of the key themes arising from the conference and the varying approaches
   to policing in the community of different police services across Europe, ranging from law
   enforcement to having a statutory role in ensuring community well-being.

Members considered correspondence received from the Department of Justice in relation to the Garda Síochána (Digital Management and Facial Recognition Technology) Bill 2023, advising that that the government had given its approval for the drafting of Heads of Bill and the preparation of a second Bill that seeks to provide for Garda use of facial technology in Irish law and scheduled for publication by year end. Members considered previous discussions on the use of body worn cameras and facial recognition technology, including the risks associated with legislating for an individual technology, protecting the vulnerable, together with human rights and data protection considerations and concerns. Following discussion, it was agreed that there would be merit in tabling an agenda item on policing and technology before the end of the year, with a focus on the protection of victims.

#### 6.4 Audit and Risk Committee

Members were provided with a verbal update in relation to a meeting of the Committee that had taken place on 19 June, including in relation to the Internal Auditors' Annual Report 2022. Members were advised that the Annual Report to the Audit and Risk Committee had been presented by the internal auditors at the meeting. The Committee Chair also advised that detailed consideration had been given by the Committee to outstanding audit recommendations and consequently a number of recommendations had been approved for immediate closure, while others remained in progress. A summary of work to progress the closure of these recommendations was provided to the Members. The Committee Chair advised that a revised Risk Appetite Statement for the Authority had been considered and was recommended for adoption by the Authority.

### 7. Risk Management

Members considered the monthly risk management report, provided in accordance with the Authority's Risk Management Policy. Members considered and approved a revised Risk Appetite Statement, as recommended by the Audit and Risk Committee, subject to a minor amendment in relation to reputational risk.

### 8. Policing, Security and Community Safety Bill-Implementation Update

Members were provided with an overview of work to progress the implementation of the Policing, Security and Community Safety (PSCS) Bill, through the Department of Justice, coordinated through the PSCS

Transition Programme. Members were apprised of work being done by the Executive, in conjunction with the Garda Inspectorate, to progress the establishment of the Policing and Community Safety Authority (PCSA), including the finalisation of a 'shaping document' for the PCSA and the development of a supporting business case for submission to the Department of Justice. Members sought and were provided with clarification regarding timeframes for the finalisation and submission of both documents to the Department. Members agreed the importance of ensuring that the ambition for the PCSA, as set out in legislation, would be clearly articulated in any submissions to the Department.

### 9. Garda Síochána Annual Report 2022

Members considered the Garda Síochána Annual Report 2022, having regard to the direction previously issued in respect of the form of the Annual Report. Members noted that the extent and nature of information provided in the Annual Report was significantly enhanced, when compared with previous annual reports, although more comprehensive financial reporting would still be desirable, in the context of the annual budget. Members discussed the importance of the Annual Report 2022 to the Commissioner in conveying some of the challenges faced by the organisation in the delivery of a policing service in the state. Following discussion, the Authority agreed that the Garda Síochána Annual Report 2022 would be submitted to the Minister, together with a short commentary on the extent to which the direction issued by the Authority was addressed.

### 10. Review of Invalid and Unwarranted Closure of CAD999 Incidents

Members considered a report provided by Mr Derek Penman detailing the outcomes of additional call listening activity undertaken by him and by officers of the Authority in the preceding months. The Chief Executive advised that she continued to attend meetings of the Garda Síochána CAD Review Implementation Group meetings in an observer status. Members were advised that good progress was being made in relation to the implementation of recommendations contained in Mr Penman's report, noting that some were contingent on the roll-out of 'Garda Safe', the system to replace CAD. The Chief Executive also advised that Mr Penman would undertake further work for the Authority in the last quarter of 2023 to assess the extent to which the recommendations have been fully addressed.

Members discussed the report findings and sought clarification in relation to the scope of calls in the additional listening activity, having regard to previous work undertaken to classify 'high risk' and 'serious cohort' incidents. Following discussion, it was agreed that correspondence would issue to the Commissioner, seeking clarification in relation to the CAD incidents that were in the additional call listening activity undertaken by Mr Penman. It was also agreed that the findings provided to the Authority by Mr Penman would be published on the Authority's website.

Arising from the review undertaken, and having regard to the future functions of the Policing and Community Safety Authority, Members had a wide-ranging discussion in relation to access to information to enable oversight and inspection. In this regard, Members considered the lengthy, protracted process involved in achieving access to information for the purposes of the CAD999 review. While noting the particular circumstances of the CAD999 review, the nature of the information being accessed and the

importance of the appropriate treatment and handling of information, the Authority agreed that unimpeded access to any such information was, and would continue to be, of critical importance from the perspective of independent, statutory oversight. From that perspective, the importance of ensuring an appropriate legislative framework to enable such oversight was also emphasised. Following discussion, it was agreed that the matter would be brought again to the attention of the Department of Justice to renew the Authority's expression of the importance of this being fully facilitated in the new legislation.

At the outset of the meeting, Members discussed a number of matters with the Commissioner including:

Access to the PULSE system by GSOC and associated governance and audit considerations.

- A recent apology issued to Mr Pat Carey by the Commissioner under a settlement of Mr Carey's High Court action. The Commissioner provided the Authority with an overview of the process of investigation that had been undertaken to establish how information relating to a criminal investigation had found its way into the public domain. The Commissioner undertook to provide an overview of that investigation in his next subsequent monthly report to the Authority. The Commissioner also undertook to address the matter at the meeting in public.
- 'Operation Domhain'-Updated Strategic Operational Guidance for the policing of protests, recently issued to Garda members. Members sought to ascertain whether feedback had been received in relation to the document's content and its applicability and usefulness in an operational context, in particular in determining when to escalate a policing response. The Commissioner provided Members with an overview of the status of a number of anti-immigrant protests in different locations across the country and the different factors influencing the policing response of the Garda Síochána.

# 12. PSCS Bill Implementation Update

Members engaged with the Commissioner and his senior colleagues on their assessment of the progress of the PSCS Bill Implementation Programme, from the perspective of the Garda Síochána. The Authority was apprised of the current principal difficulty in respect of the status of Garda staff members and of the ongoing engagements with the Department of Justice and the Department of Public Expenditure, National Development Plan Delivery and Reform in this regard. Members were provided with an overview of the impact of the continuing uncertainty from a variety of perspectives and of the measures being adopted by the Garda Síochána to address those elements within its control. Following discussion, it was agreed that the Commissioner would provide a written update in relation to the issues concerned.

### 13. Garda Síochána Annual Report

The Chairperson further advised that the Authority would be highlighting the desirability of the provision of more detailed information in relation to Garda Síochána finances, in addition to the opportunity for the Commissioner to communicate the challenges facing the organisation in the delivery of a policing service. Members commended the Commissioner and his team on the quality of the annual report and the extent of information provided to the public.

# 14. Human Resources for an Effective Policing Service

Matters relating to this agenda item were discussed under item 12 and no additional matters were addressed under this agenda item.

### 15. Conduct and Disciplinary Processes in the Garda Síochána

Members engaged with the Commissioner and his senior colleagues on the approach to duty status of Garda members, in circumstances where charges are preferred against them, including the processes in place for considering suspensions and related decision-making and governance arrangements.

### 16. Fatal Shooting of Mr George Nkencho

Members discussed with the Commissioner the completion of the investigation by GSOC of the fatal shooting of Mr George Nkencho and the forwarding of a file to the Director of Public Prosecutions (DPP). The Commissioner advised that the determination of the DPP was awaited.
