<u>Donegal Joint Policing Committee</u> <u>Annual Report 2018</u>

Introduction

Donegal Joint Policing Committee is a partnership between Government (as represented by Council members and executives, and Oireachtas members) our local communities (represented through Donegal PPN) and An Garda Siochana.

The objective of the JPC is to attempt to allow the three pillars of the partnership to achieve more working together than they would working individually for the communities of our county.

2018 was a productive year for Donegal Joint Policing Committee. We have agreed the five themes of our Strategic Plan for the remainder of the term of the committee and put structures in place to agree actions under each theme and continue to implement those actions.

The five themes that we have selected represent the major social and community safety issues that communities face in this county.

Attempting to address common issues along with communities that we share a border with is a logical thing to do and hopefully we can continue to work with Councils across the border to develop projects similar to the cross border drink driving campaign that was launched in the run up to Christmas.

The five themes of the Donegal JPC Strategic Plan are:

- Rural Isolation & Community Policing
- Public Order & Anti Social Behaviour
- Drugs
- Road Safety
- Cross Border Crime Prevention Initiatives

The JPC identified that it was necessary to study each of the three themes in some detail and take advice from experts who deal with our communities in relation to these issues to allow the committee to determine what actions would have a positive impact. To this end, the work of the sub groups has been invaluable, and all the JPC members who have participated must be acknowledged for taking on an increased commitment, to ensure the work produced by the sub groups have a positive legacy.

Implementation of the Strategic Plan is facilitated through a number of committees and structures, including the secretariat, steering committee and the road safety working group. The three sub groups of the JPC consider the themes of Rural Isolation & Community Policing, Public Order & Anti Social Behaviour and Drugs. The role of the sub groups is to consider in detail the issues relating to these themes, along with sector experts, and revert to the JPC with proposed interventions.

Donegal Joint Policing Committee and its sub groups continued to meet on a regular basis throughout 2018. Crime trends and statistics are discussed at meetings which highlight issues that the JPC strive to respond to through its Strategic Plan. Local issues are continuously highlighted by elected members and PPN community representatives which allow them to be dealt with by the relevant stakeholders. The JPC has been able to continue to deliver initiatives that have a positive impact on our communities, such as discouraging anti social behaviour, promoting an anti drink driving message and developing a network of community alert and neighbourhood watch groups. A consistent message coming from all stakeholders is the lack of Garda resources and the JPC take every available opportunity to raise this issue nationally.

1	Road Safety	Donegal is fortunate to have an active and successful Road Safety Working Group in the county and it is beneficial to the work of that group that the JPC have identified road safety as one of our strategic themes. The Donegal Road Safety Working Group is an interagency group consisting of Donegal County Council, Transport Infrastructure Ireland, An Garda Siochana, Road Safety Authority, Donegal Youth Service, Donegal ETB, Pro Social Drivers Programme and HSE Ambulance Service. The group meet on a monthly basis to develop and implement road safety initiatives and campaigns with the objective of improving road safety for all road users. The DRSWG is committed to working with local communities and groups throughout the county so as they can work towards playing their part	The Donegal Road Safety Working Group continues to organise the Road Safe Road Show as a direct approach to improving road safety and reducing the devastating impact of road traffic collisions on communities and families in the county. The show is attended annually by over 2,500 students and learners from post-primary schools, Youthreach and other training centres. The DRSWG maintains close links to relevant authorities in Northern Ireland to encourage safe driving through road safety campaigns such as anti drink driving campaigns, bank holiday road safety campaigns, bank holiday road safety campaigns and cross border young driver safety campaigns. A full calendar of road safety awareness campaigns is agreed at the start of each year by the group and these are rolled out consistently as education and	The Donegal Road Safety Working Group currently has partnerships in place with CLG Dhún na nGall, Ulster GAA Health & Wellbeing Committee, Finn Harps FC, Donegal Daily website and Donegal Democrat in relation to the promotion of Road Safety in Donegal. Education is the central focus of the DRSWG, changing attitudes, behaviour and the culture of road users are key targets we will continue to work to improve these and in turn save lives. The DRSWG with the assistance of Pro Social Ireland has also been delivering road safety programmes in Schools and Youth reach centres in Donegal. Reducing the number of deaths and injuries on Donegal's roads is a responsibility we all share. There was a total of ten road fatalities in Donegal in 2018.

2	Public Order and Anti Social Behaviour	The Public Order and Anti Social Behaviour sub group has considered issues of public order and anti social behaviour and how the JPC can best respond to these issues. The sub group received a number of presentations that outlined that the majority of issues for policing are related to the more urban areas and specifically to the night time economy. The sub group visited Letterkenny Garda Station to view the current CCTV system in operation and viewed its benefits. The group agreed that it was a priority to extend the current CCTV system in Letterkenny	The Letterkenny CCTV system was extended in 2017, with a link to the Bernard McGlinchey Town Park being added. Donegal JPC received a presentation in April 2018 from colleagues in Cavan/Monaghan in relation to a scheme they have implemented there where property can be marked using the eircode of the owner which assists in recovering stolen goods and also acts as a deterrent to thieves. It is proposed to deliver a similar scheme in Donegal.	To date, Donegal JPC have approved two applications in principal and they have been forwarded to the national fund, one an extension of the Letterkenny CCTV scheme and a new, bespoke scheme for the Ballybofey / Stranorlar area. Subject to Data Protection issues being resolved, it is hoped that both applications will be progressed soon. Donegal County Council allocated a budget to purchase a Property Marking Machine in 2019. The PPN also agreed to purchase a machine. The procurement of the machines is ongoing.

5	Drugs	The fifth theme of the Donegal JPC Strategic Plan is drugs, the Drugs sub group have met on a number of occasions in relation to what initiatives could be developed to assist in the fight against drugs. The sub group is aware of the need to avoid duplication and received presentations from the North West Regional Task Force and the Foroige Youth Drugs Office. The negative impact that alcohol has was highlighted, not just on the person consuming but also the potential impact alcohol has on domestic violence, sexual abuse and human trafficking cases. <u>ITEM 2 -</u> Please highlight three key achievements of the JPC during the year and give reasons why these are considered to be significant?

Achievement 1

Donegal JPC, in conjunction with the Donegal Rally organising committee, held an awareness raising campaign in June 2018 targeted at attendees of the Donegal Rally. The message was that of respectful attendance, to attend the rally and behave in a manner that is respectful to the local area.

Achievement 2

The Donegal Network of Community Alert and Neighbourhood Watch Groups held an information event as part of "One Donegal – Social Inclusion Week 2018". This event allowed members of groups to hear about current initiatives as well as potential projects that groups could undertake. The event took the format of presentations and an opportunity for groups to engage with experts and providers through an information stand setting. Among the topics discussed on the day were the Joint Policing Committee, road safety, cyber crime, fire safety and potential funding sources for groups.

Achievement 3

Donegal JPC successfully lobbied Donegal County Council and the PPN to agree to purchase Property Marking Machines. The procurement and purchase of the machines was commenced in late 2018 with the delivery, training and roll out of a Programme for delivery of the service to people in the County expected to take place in 2019.
