Annual Report of the Joint Policing Committees 2022

Section 36 of the Garda Síochána Act 2005 provided for the establishment in 2006 of Joint Policing Committees (JPCs) in each Local Authority. In Dublin City, this consisted of both a Citywide Joint Policing Committee and five Area Subcommittees corresponding with the five operational areas of the City Council.

Guidelines for the operation of Joint Policing Committees were originally introduced by the Department of Justice in 2008 and revised in August 2014 to cover the period 2014 – 2019 (Council Report no. 288/2014 refers).

With effect from April 2016, responsibility for issuing guidelines in respect of Joint Policing Committees comes under the remit of the Policing Authority, which was established by the then-Minister for Justice and Equality in January 2016 to oversee the performance of An Garda Síochána in relation to policing services in Ireland. **The Authority's representatives continued to attend JPC meetings during 2022.**

The Authority produced new guidelines in Autumn 2022; which were discussed at the annual conference and agreed with both the Chairs of all the JPC's and Chief Executives of all the Local Authorities, at their annual conference in August 2022. These revised guidelines were subsequently issued to the Dublin City Joint Policing Committee, the 4 Joint Policing Subcommittees and the North Inner City Local Community Safety Partnership (LCSP) in November 2022.

The main purpose of the Joint Policing Committees is to provide a forum whereby a Local Authority and Senior Garda personnel, with participation from Local Authority members, Oireachtas members and community/business interests, can discuss and make recommendations on matters affecting the policing of the area.

A Strategy Document was originally prepared for the Council term 2019-2024, with the objective of having each of the 6 Joint Policing Committees focus primarily on 3 key issues for the duration. Owing to the fact that the JPC structure remains under review, and the recent establishment of a 2-year Pilot Community Safety Partnership in the North Inner City Electoral Area which, it is envisaged, will replace the Joint Policing Committee in that area going forward (Appendix 1 refers), it was decided to retain these objectives for the foreseeable until such changes come into effect. These objections are listed as follows:

Three high priority issues for Dublin City six-year (2019-2024) Strategic Plan:

- 1. Community Safety / Confidence-building
- 2. Antisocial Behaviour Housing Estates
- 3. Street Crime

The following action matters form the basis of the annual work plans for each of the six committees:

It is important to note that these headings are not exclusive and Committees are also encouraged to report under any other headings deemed appropriate for their respective areas. Separate issues are often progressed via each Committee's respective Annual Work Plans.

Meetings of the Dublin City Joint Policing Committee are held every two months and currently take place via the remote video conferencing, Zoom. One Hybrid meeting took place in 2022.

The Joint Policing Committee is required to submit a report to the City Council annually on the performance of its functions during the preceding year, which is set out hereunder.

		during 2022. <u>High Level Group on Street Issues</u> (HLG) This group meets monthly and is chaired by the Lord Mayor. Its membership includes representatives from Dublin City Council (DCC), An Garda Síochána (AGS), Health Service Executive (HSE) and Ana Liffey Drug Project (ALDP). The focus of this group is on issues affecting the city centre and bordering streets only, specifically drugs, drug-
		dealing, street drinking, antisocial behaviour etc. and bordering streets. <u>Ana Liffey Drug Project (ALDP) &</u> <u>Law Engagement & Assisted Recovery</u> (<u>LEAR) Project</u> The project is led operationally by Ana Liffey Drug Project (ALDP) and consists of a frontline multidisciplinary team with members of Ana Liffey, An Garda Siochána (AGS) and Dublin Region Homeless Executive (DRHE), providing intensive case management services

to people entrenched in street life in the city centre. The project supports people who have complex and multiple needs such as addiction, criminality, homelessness and mental health to engage effectively with support services, often for the first time, and to identify and achieve their goals. A key focus of the project is supporting people to move away from criminality and antisocial behaviour and towards their personal recovery.

Formerly known as the 'Assertive Case Management' project – the service was renamed as the Law Engagement & Assisted Recovery (LEAR) project. This name change was announced on 3rd June 2022; and it encapsulates Ana Liffey's partnership work of AGS, their proactive work with the Courts and Probation Service, in addition to their strong partnership work with a wide range of agencies to help people meet diverse goals and to achieve recovery from a problematic lifestyle to the standard the person desires.

Since 2014, the LEAR project has had boots on the ground in Dublin City Centre. The LEAR project has been active in Dublin 1 and Dublin 2 since 2014. In 2021, the project expanded to work in Dublin 8; and in 2022 the project has been further expanded to

Members of the Students Safety Group and Gardaí set up a bicycle checkpoint on the grounds of UCD. Cyclists going through the checkpoint were given bike safety and security advice. Over 200 sets of lights were also handed out to cyclists.	

owners. All were advised to take a picture of their bicycle with identifying marks clearly visible and record details on property marking cards provided. This was also deployed in shopping areas where there is a high footfall to remind people of the need for good security for their bikes.

Continued to implement bye-laws and existing legislation to combat drinking on open spaces and in public places

There was regular engagement with all local businesses and licensees across the South East Area, to ensure compliance with the Intoxicating Liquor Act and also that potential fines are outlined for selling alcohol to underage and/or drunk individuals.

Test Purchasing operations were carried out periodically to ensure Licence Holders were not selling drink to minors.

Owners / managers / staff were reminded to be vigilant in relation to the Underage Policy and encouraged to report any instances or suspicions of persons buying alcohol on behalf of minors.

Meeting was held in March by Pearse Street with the Licensing Trade in the City Centre regards the St. Patrick's Festival.

Gardai continued to target drinking in open spaces with intelligence-led policing concentrating on known hot spots in accordance with **Operation Soteria**.

Particular focus was paid on areas highlighted as a result of Community Safety Forums and Community Impact Assessment.A number of events took place in 2022, including matches in the Aviva stadium, all of which ran without serious incidents.

All applications for a licence to sell alcohol were strictly vetted by a Garda Sergeant in advance of any Court application and

Operation Irene was enforced in all public parks / green areas / open spaces and these were regularly subject to high visibility policing. Both the Public Order Act and Intoxicating Liquor Act are utilised where breaches occur.

Create an awareness amongst the citizens of the South East Area of Crime Prevention and Community Safety Initiatives

Operation Thor continued to be in operation. All burglaries reported are subject to Technical Examination. Crime Prevention advice is given to victims.

The Burglary Response Unit continued to tackle offenders.

The Divisional CPO produced an information package concerning Retail security and Online Shopping and distributed it through "Dublin Town" to all their retail stakeholders.

Community Policing members continue to deliver safety information to residents & stakeholders within their individual CPA's.

Community Gardaí have maintained links with the community have additionally arranged for premises to be visited by Crime Prevention Officers.

Continued to recognise and respond to the needs of victims of crime and to ensure protection of vulnerable persons and groups

Gardaí continued to conduct Domestic Violence call backs under **Operation Faoiseamh** and ensure that any concerns from victims are being addressed.

		In-person call-backs to victims of domestic abuse and residential burglaries were conducted by Community Gardaí within 7 days of an incident. Community Gardaí in Pearse Street organised a joint initiative with CUS Leeson Street to do a clean-up of the communal garden in Powerscourt/Verschoyle Court , Dublin 2 on Friday 4 th of March 2022
		On Saturday the 14 th of May, Pearse Street Community Policing Unit hosted an Open Day which was enjoyed by members of the public and the local community.
		Gardaí and Garda Staff (Victim Services) maintain a full service to victims of crime with a particular focus on vulnerable persons and groups.
		SONAS (Freedom from Domestic Violence) visited Irishtown Garda Station on the 3 rd of August, which was organised by Community Policing.
		Local Community Gardaí regularly perform welfare checks on elderly and vulnerable people in the community and have built up a register of older and vulnerable persons that are visited and reassured.
		Community Gardaí reminded elderly and vulnerable people about "bogus tradespeople and cold callers" to the door and alerted people to e-mail scams and text messages attempting to gain access to their bank accounts etc. In serious incidents,
		Family Liaison Officers kept in contact with families and regularly update them as to progress in their case.

The Divisional Garda Victim Service Office also liaise with
victims of crime offering practical support and assistance.

Support the Neighbourhood Watch Schemes

Community Gardaí continued to liaise with local representatives and residents in response to specific issues, targeting anti-social and or criminal behaviour.

Continued liaison with UCD, RCSI, TCD campus, Union reps, staff and residents throughout 2022.

Regular meetings were held with each neighbourhood watch committee attended by the Community Policing Sergeants or Gardaí.

Designated liaison Community Garda for each sector in the subdistrict provided assistance with crime prevention advice as well as local initiatives run by the various groups.

On the 22nd of September, Community Policing members in Donnybrook relaunched **'Campus Watch**' as part of their crime prevention strategy at UCD Belfield Campus.

On the 15th of November, an AGM of the Donnybrook District Neighbourhood Watch / Residents Associations was held at the Aviva Stadium. A number of speakers gave talks on the night in relation to Crime Prevention, Cyber Security and Domestic Violence.

Neighbourhood Watch schemes in the District remained active and each scheme has a designated Neighbourhood Watch Garda assigned to it who will meet with the street co-ordinator.

Crime prevention and advice posters / leaflets / brochures etc. are distributed among the scheme members by way of direct

contact / e-mails etc. and people are encouraged to visit the
Garda website to avail of more information.

Community Gardaí set up information stands at various locations in the district and also attend local activities / meetings where material can be distributed and discussed in detail.

The Divisional Crime Prevention Officer visited businesses and individuals to provide detailed security and safety advice.

Terenure Community Gardaí established a new Neighbourhood Watch scheme in an area of Rathgar.

Reduce Property Crimes such as burglaries, thefts and robberies

The **Operation Thor, Winter Initiative** operated in 2022 and incorporated the deployment of all operational personnel (crime detective units, divisional crime task force, drugs units,

community policing units, roads policing units, CIO's and crime prevention officers). The objective was to have a focused, targeted and integrated approach to criminals involved in committing Burglary related crime in the Winter months.

The **Divisional Burglary Response Unit** carried out targeted patrols across the SE Area.

The **Crime Prevention Officer** conducted a number of security surveys and assessments to reduce the incidents of property crimes and targeted intelligence-led patrolling were utilised to reduce burglaries.

Prolific offenders were targeted, objections to bail made in District Court and Bail revoked before the where breaches of bail were detected. "**Days of Action**" were implemented to target known offenders/wanted criminals. Searches were conducted for stolen property and Court warrants are executed.

The Divisional **Burglary Response Unit** carried out targeted patrols across the SE Area.

High Visibility checkpoints were set up in areas of recent crime to disrupt mobile criminals. Uniform Gardaí both on foot and on Mountain Bikes concentrated on specific areas and Divisional resources such as the Burglary Response Unit were utilised to perform extensive patrolling of areas and housing estates.

Crime trends were analyzed to identify hotspots and Garda resources are utilised to provide early intervention to combat such crime.

Continued to work together to provide alternatives to anti-social behaviour for young people (target audience 10 -12 years old)

Youth At Risk (10-21 years) is the DCSWP core programme dedicated to providing opportunities for young people to take part in sport and physical activity on an ongoing basis thereby mitigating anti-social activity and behaviour. Annual Ballymun Safety Fora JPC Report 2022

The Safer Ballymun is a partnership between the Community, Dublin City Council, the Drugs Task Force and An Garda Siochana. The focus is to engage in collaborative discussions to explore solutions to local safety concerns.

The Ballymun Safety Forum Steering Committee held 3 meetings in 2022

- Wednesday 27th April
- Tuesday 25th October
- Monday 5th December

Dublin City Council & An Garda Síochána met on the following dates to discuss Safety issues and agree actions to be implemented under the Safer Ballymun Strategy

- Wednesday 26th January
- Wednesday 2nd February
- Tuesday 10th May
- Tuesday 6th September

Once restrictions lifted the Ballymun Safety Forum Meeting recommenced in person public meetings were held on

- Wednesday 15th June
- Tuesday 4th October

Dublin City Council have established a Youth Advocacy Group in Ballymun which have engaged with the Safer Ballymun Network and will be represented on the Safer Ballymun Steering Committee. It is the aim of the Safer Ballymun Forum to bring their voices, ideas and potential solutions to issues raised to fruition in the coming year.

The main safety matters raised during 2022 were

- Open drug dealing around the Dolmen Court
- Anti-social behaviour & drug dealing at St. Josephs Hill
- Increased levels of anti-social behaviour and intimidation at Poppintree Sports Centre
- Increased number of scramblers and stolen cars in the area
- Large gatherings of youths around Poppintree Parade shops
- Increased levels of anti-social behaviour at Hampton Woods

Our Housing Manager and Project Estate Team have continued to work closely with the local Gardaí to follow up on and investigate complaints as received. DCC have served a number of Tenancy Warnings, secured an eviction, have processed a Section 20 request to An Garda Síochána (to remove illegal occupiers from DCC property). Short term actions have being agreed and implemented to address anti-social behaviour and drug dealing in specific locations. Including local project on St. Josephs Hill in conjunction with DCC, AGS, Easy Street, St. Josephs School, the Jobs Centre and local residents, The Ballyrunners completed a number of clean up's and a planting project on St Joseph's Hill. The Arts Workshop took place in St Joseph's School with 5th and 6th class students whereby artists collated design templates. A mural was unveiled in conjunction with a very successful Family Fun Day followed by an additional planting project at the Dane Road entrance to the hill and community mediation work between relevant local community representatives.

Working to enhance Our City, Our Communities and Our Safety

Below is an update on the activities that were reported on at the board meeting for the LCSP held on the 9th of February.

A presentation was made to the Partnership by Dublin Fire Brigade on a Risk Reduction Management Plan for the NIC; it is hoped that a pilot of this programme will be run in cooperation with the LCSP of the NIC.

The Wolfe Tone Park hiring process has concluded and there were over 100 applications. 3 candidates were successful and have accepted 2 full-time and 1 part-time positions.

O' Connell Street CSW has had a big attraction with over 200 applicants, interviews were held in February 2023 with 1 position offered. No other successful candidates from this round, second round of interviews scheduled for the coming week, w/e 7th of April.

It is intended to launch the CSW scheme in the coming month. DublinTown, principal employer, has applied to the Garda National Vetting Bureau to register as an approved agent to request garda clearance. The Partnership is supporting this application and it is hoped this process will be completed without further delay. The CSW scheme will commence with induction and training once DublinTown are listed. A launch date will be agreed and will be supported by a press call, to which all stakeholders will be invited to meet with the team.

The DRIVE lead position (Drug Related Intimidation and Violence Engagement Lead) this position was advertised in December; the advertisement was extended to run for an additional 3 weeks to account for the holiday period. Interviews are now concluded (March 2023) and the position has been offered out to the successful candidate. Inspector Ken Hoare has joined Working Group 1, On Street Drug dealing, Drug Taking and will work closely with the DRIVE Lead and is gaining a clear picture of Drug related intimidation in the NIC.

LEAR (Law Engagement and Assisted Recovery Project) is establishing itself in the community. The coordinator of the LEAR team gave a presentation to the Local Community Gardaí, Local Housing Officers, with the objective of increasing referrals to the team from those that would benefit, but are not on the street.

As a result of the presentation to the Local Youth Workers, to explore how to reach the 'Hard to Reach' as described by legislation, it was revealed that there is a gap in engagement with the under 18's where misuse of substance is a difficulty. The HSE has extended the funding to include a part time under 18's LEAR engagement worker. However, the Partnership is currently working with the HAY project, Ana Liffey and the HSE to ensure this position is clarified and procedures are in place to support the position.

At time of the Board meeting, it was reported that CES had submitted a draft report to the Department of Justice. That report is now concluded and will be launched in April.

The Partnership has proceeded to compile a first draft of the Community Safety Plan. During the facilitated working groups that were held in 2022, in addition to policing, 5 themes were identified under which the Partnership is now working. The themes are as follows:

- o Drugs, Anti-Social Inclusion Health
- o Family Youth and Community
- o Education and Employment
- Integration Ethnic and Multi Faith Inclusion
- \circ Environment

Finally at the board meeting on the 9th of February the Chair, Cormac O'Donnchú tendered his resignation.
