# INTRODUCTION

Section 35 of Garda Síochána Act, 2005 provides for the establishment of Joint Policing Committees (JPC). The County Galway Joint Policing Committee was established in 2009.

The County Galway JPC committee comprises 34 members representing Galway County Council (elected members and officials), members of the Oireachtas in the county, An Garda Síochána and the Community and Voluntary sector.

The JPC's function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of Galway County Council's administrative area, and to keep under review:

- the levels and patterns of crime, disorder and anti-social behavior in that area, and
- the factors underlying and contributing to the levels of crime, disorder and antisocial behavior in the area

County Galway JPC has a Strategic Plan for the period 2015-2021 which contains four high-priority objectives contributing to the improved safety and quality of life in the community.

This Annual Report 2017 outlines how the County Galway Joint Policing Committee carried out its function for this period in compliance with section 36(2) of the Garda Síochána Act 2005 and in accordance with the revised Joint Policing Committee guidelines of 2014.

# ITEM 2: KEY ACHIEVEMENTS 2017

#### Achievement 1/2017

# **'Cleaner Greener Galway' Initiative**

During 2017, the *Illegal Dumping & Littering Sub-Committee led on an initiative 'Cleaner Greener Galway'* which was a collaborative approach to anti-litter and illegal dumping by Galway County Council working together with sporting, voluntary, business organisations and An Garda Síochána.

The Minister for Communications, Climate Action and Environment, Denis Naughten T.D. launched Galway County Council's new, proactive anti-litter and illegal dumping awareness campaign - "A Cleaner, Greener, Galway!" earlier this year".



Representatives of over 100 of Galway's top athletes and high profile sporting faces from across Galway GAA, Connacht Rugby and Galway United joined Minister Naughten, and the Cathaoirleach of the County, Cllr. Michael Connolly, and members of Galway County Council to show their support for "A Cleaner, Greener Galway". The message from the sporting community to the people of Galway is "don't drop the ball on litter" as Galway County Council embarked on a highly proactive and all-inclusive anti-litter and illegal dumping awareness campaign throughout the county.



In addition, desire amongst the business community of Galway for this collaborative initiative by Galway County Council is hugely positive with Galway businesses offering supports to promote the message of "A Cleaner, Greener, Galway"!

Also significant support for "A Cleaner, Greener, Galway" was shown by An Garda Síochána with proactive policing when it comes to illegal dumping and An Garda Síochána will be vigilant in deploying illegal dumping check points throughout county Galway in an effort to continue to curb illegal dumping as part of this high profile anti-litter campaign.

Galway County Council is promoting "A Cleaner, Greener, Galway" campaign message using digital messaging, social media channels and traditional media and marketing tools throughout schools, sporting clubs, societies, voluntary and community organisations including Tidy Towns and of course businesses and An Garda Síochána, inspiring the people and communities of Galway to be litter conscious at all times as not dropping litter is ultimately the solution to Keeping Galway Litter free.



The aim of this collective and shared campaign is to generate maximum awareness amongst the people of Galway with a view to ultimately eliminating litter and illegal dumping from Galway's environment and eradicating the need for clean ups. Thus creating "a cleaner, greener, Galway" for everyone to enjoy.

This action is significant as while Galway gets closer to the European Region of Gastronomy 2018 designation and to the Galway 2020 European Capital of Culture designation, it is the aim of Galway County Council to show the ultimate in local authority leadership by having "a cleaner, greener Galway" for Galwegians and visitors alike.

# Achievement 2/2017

During 2017, the Joint Policing Committee received a number of briefings to aid delivery on the strategic objectives as detailed in the JPC Strategic Plan 2015 – 2021.

In accordance with the strategy to promote and advise the public of the importance of road safety, the Joint Policing Committee received a briefing from Ms. Geraldine Cooley, A/Roads Safety Officer on the Draft Road Safety Strategy with comments invited from the JPC prior to its adoption.

Ms. Cooley advised the Committee that the three-year Strategy was a collaboration between the County and City Councils, An Garda Síochána, Transport Infrastructure Ireland and the Road Safety Authority. She said that the Strategy outlined a series of actions to be implemented across Galway by 2020 to make roads safer and the comprehensive Action Plans for Galway included a variety of awareness and educational programmes for children, pedestrians and motorists and car seat checking events, better enforcement and the provision of road safety measures is featured.



The Education & Awareness Sub Committee in conjunction with An Garda Siochána and the Road Safety Officer, in line with the Road Safety Plan 2017-2020, assisted in highlighting road safety awareness to young children and the importance of being visible at all times through its many programmes held throughout the year to include the 'Be Bright', 'National High Visibility Day', 'and Are you daylighted' campaigns.



Cllr. Aidan Donohue, Chair of the Education & Awareness Sub Committee, along with Deirdre Caulfield, Roads Safety Officer, GCC and members from An Garda Síochána who co-ordinated the 'Be Bright' Campaign on 5th October, 2017.

The aim of the event was to encourage all pupils to wear their high visibility vests when walking or cycling to school. The Junior and Senior Infants classes took part in a walk from the school wearing their high visibility vests, courtesy of the Road Safety Authority. Ms.

Deirdre Caulfield, Road Safety Officer, advised the pupils on the Safe Cross Code – STOP. WAIT. LOOK. LISTEN! It is hoped that by highlighting road safety awareness to the young children, that they will see the importance of being visible at all times.

In relation to the strategic objective addressing Crime Prevention/Personal Safety to promote the use of Community based CCTV, the Joint Policing Committee was advised of the new Community CCTV Grant Aid Scheme, announced by the Department of Justice and Equality, where eligible community groups could apply for grant-aid of up to 60% of the total capital cost of a proposed CCTV system, up to a maximum grant of €40,000. Upon approval of the grant, the applicant would receive an up-front payment of 50% of the grant with the balance to be paid when the system is fully operational, with some of the key objectives of the Scheme being to enhance existing policing provision within the community, to assist in the prevention and reduction of local crime, disorder and anti-social activity and to increase community involvement in the provision of legitimate, integrated responses to prevent and reduce crime in local areas in association with appropriate agencies. €1 million has been allocated in Budget 2017 to support qualifying community groups with the intention that the scheme will run for 3 years with funding of €1 million being made. In order to qualify for grant-aid grant applications must be approved by the Joint Policing Committee.



#### Achievement 3/2017

The three sub-committees of the JPC (*Illegal Dumping & Litter Awareness Sub-Committee, Education & Awareness – School Programme Sub-Committee and Crime Prevention/Personal Safety Sub-Committee*), which were established in late 2016, continued in 2017 to deliver on the strategic objectives of the Strategic Plan 2015 – 2021.

The key actions and projects initiated and undertaken by each of the three Committees in 2017is outlined above in the table outlined in **Item 1 Summary of Progress for 2017**.

# Achievement 4/2017

The Crime Prevention/Personal Safety sub-committee and supporting Council staff were commended by the An Garda Siochána for their input into CCTV Schemes as the new Code of Practice issued by the Dept. of Justice and other associated documents were based on the work being undertaken by Galway County Council and following site visits by senior Garda management whereby Galway County Council is now used as a benchmark for other community based CCTV schemes across the county.

# ITEM 3: PUBLIC MEETING HOSTED BY THE JPC DURING THE YEAR.

The 2017 County Galway JPC public meeting was held on 6<sup>th</sup> November 2017 in Peacockes Hotel, Maam Cross, Conamara. Members of the public were invited to this meeting with up to 50 persons attending on the night.

The Agenda included the following items:

- Community Watch
- CCTV
- Illegal Dumping/Littering
- Traffic inappropriate behaviour/joy riding
- Crime Prevention Initiatives
- Anti-Social Behaviour

Questions to be considered by the Joint Policing Committee were also invited from the public prior to the meeting on general policing matters affecting the policing of the County of Galway. Two written questions were submitted which related to road safety/speeding.

Some of the following topics were also raised and discussed at the Meeting:

- Speed limit signage.
- Speeding on roads consideration to be given to the use of Go Safe vans on roads where speeding is taking place.
- The benefits of text-alert, community alert and neighbourhood watch schemes.
- Importance of not leaving valuables in car while attending events.
- Necessity for rural Garda stations to remain open to deter crime in areas.
- Group cycling, mainly at weekends, cycling two and more abreast, is very dangerous.
- The importance of hi-vis jackets and the promotion of same to all, not just school going children.
- The necessity for the installation of CCTV cameras at strategic locations and bogs to prevent crime and illegal dumping.

Cllr. Peter Roche, Chairperson of the JPC, thanked all who attended the meeting and who raised concerns/issues and acknowledged that the JPC Public meetings provide an excellent opportunity for the public to engage with the local authority and the Gardaí in matters relating to the general policing of the county.
