## **Message from the Chairman of the County Galway Joint Policing Committee**

As Chairperson of the County Galway Joint Policing Committee, I welcome the publication of the 2016 Annual Report. The Report details the work of the Committee in delivering on the objectives of the Strategic Plan 2015 – 2021 and is an important means of communicating the role and work of the Committee.

The Joint Policing Committee aims to develop greater consultation, cooperation and synergy on policing and crime issues between An Garda Síochána, the Local Authority, Community Representatives and the Elected Local Representatives. During 2016, the JPC continued to take a strategic approach to its work, in addressing local issues collectively and strategically.

The JPC convened on four occasions during 2016 including its Annual Public Meeting held on Monday 12<sup>th</sup> December 2016 in the Municipal District of Ballinasloe. Public meetings offer an excellent opportunity for local communities to participate and engage in relation to general policing matters affecting the policing of the County of Galway and in particular policing matters affecting their areas.

The establishment of three sub-committees during 2016, afforded the JPC the opportunity to progress strategic objectives of the 6 Year JPC Strategic Plan. I wish to acknowledge the work of the Chairs and members of the Sub-Committees for their work during 2016.

I wish to record my appreciation to An Garda Síochána and the local authority for their very valued contributions and to each member of the JPC for their continuing support in fulfilling the role and purpose of the JPC and to Galway County Council for the administration of the Committee.

## INTRODUCTION

Following the introduction of the Garda Síochána Act 2005, guidelines for the operation of Joint Policing Committees were issued in 2008 in accordance with the Act and heralded the establishment of these important partnership structures in all of the then existing local authority areas,.

A review of the operation of the Joint Policing Committees commenced in 2012, to see if there were ways in which their operation could be enhanced and ensure that they were functioning as intended. The review was managed in consultation with an Oversight Committee which included representatives of the Department of the Environment, Community and Local Government and the Garda Síochána.

Revised guidelines were developed and introduced in August 2014 as an addendum to the original guidelines. The changes made reflect feedback received during the review process as well as input received by the Department of Justice and Equality during the public consultations in relation to the preparation of a White Paper on Crime.

The revision of the guidelines was particularly timely as it allowed for the alignment of Joint Policing Committees with the new local government structures as established in the Local Government Reform Act 2014. The most significant changes to the guidelines reflect both the new local government arrangements and a strengthening of strategic and collaborative functioning within each Committee. Important changes included that;

- Committees will operate at a City and County level following the abolition of Town Councils, reflecting a more modern and streamlined approach to the management of local issues.
- Committees will develop Six Year Strategic Plans, Annual Work Plans and to report on their implementation in Annual Reports.
- Committees will have the number of community representatives increased.
- Committees will develop communications strategy to support interaction with local communities and effective and efficient coordination with other local structures is emphasised.

This Annual Report 2016 outlines how the County Galway Joint Policing Committee carried out its function for this period in compliance with section 36(2) of the Garda Síochána Act 2005 and in accordance with the revised Joint Policing Committee guidelines of 2014.

## ITEM 2: KEY ACTIONS 2016

### Action 1/2016

To deliver on the strategic objectives of the Strategic Plan 2015 – 2021, three sub-committees of the JPC were established during 2016, following agreement that the sub-committees would be the most beneficial and practical mechanism by which to progress the work of the JPC.

The membership structure allows for each sub-committee to consist of 4 Councillors, 1 Oireachtas Member, 1 Garda, and 2 Community representatives, Chaired by a Councillor and facilitated by Council staff.

#### ***Illegal Dumping & Litter Awareness Sub-Committee***

To Support and Promote awareness of litter management plans and initiatives, the negative impact of illegal dumping and littering and to promote and advise the public on the importance of reporting incidents of illegal dumping and littering.

#### ***Education & Awareness – School Programme Sub-Committee***

To promote, Education and Awareness Programmes for schools on personal safety, road safety, bullying, illegal substance abuse, and underage drinking.

#### ***Crime Prevention/Personal Safety Sub-Committee***

To increase awareness of crime prevention for communities, business, house holders and individuals.

The sub-committee structure is significant given that each sub-committee has its own specific area of focus and will engage with relevant stakeholders/agencies and authorities to identify collaborative actions and measures to address key issues specific to its terms of reference. Each sub-committee will make recommendations to the JPC to collectively address inter alia, overall issues affecting community life, crime prevention, anti-social behaviour, drug abuse, personal safety, road safety and the environment. The establishment of the sub-committees structure is a progressive step to underpin and support the JPC in fulfilling its purpose.

## Action 2/2016

During 2016, the Joint Policing Committee received a number of briefings in accordance with the various strategies identified to deliver on the strategic objectives as detailed in the Strategic Plan 2015 – 2021.

In accordance with the strategy to promote and advise the public of the importance of reporting incidents of illegal dumping and littering, the Joint Policing Committee received a briefing from Mr. Paul Moroney, Senior Engineer, Water Services & Environment on the Waste enforcement work programme and current resources available to address litter, illegal dumping, regulatory compliance and awareness.

The strategy to be pursued in relation to the strategic objective addressing Crime Prevention/Personal Safety included creating a greater awareness of the support services for victims of domestic violence. In this context, COPE Galway Waterside House presented to the JPC on domestic violence and the services of the COPE Galway Waterside House Domestic Violence Service, including the Outreach Service to County Galway.

## Action 3/2016

### High Vis Vests Pilot Initiative with Colaiste Bháile Chláir

During 2016, the **Education & Awareness – School Programme Sub-Committee lead on an initiative between** Galway County Council, the Road Safety Authority and Coláiste Bháile Chláir in conjunction with “Be Safe, Be Seen” day. High vis vests were distributed by the Council to students in Coláiste Bháile Chláir which were provided by the Road Safety Authority. The students who walk and cycle to school or to the bus undertook to wear the vests as part of the school uniform. It is considered a huge success and it is hoped that this initiative will encourage other schools to take up on this scheme.
