Invitation for representations on the Policing Authority's Strategy Statement

Introduction

The Policing Authority is an independent statutory body, established on 1 January 2016 under the Garda Síochána (Policing Authority and Miscellaneous Provisions) Act 2015. It is responsible for overseeing the performance by the Garda Síochána of its functions relating to policing services. The Policing Authority has a wide range of statutory functions including the promotion of public awareness of policing matters and supporting the continuous improvement of policing in Ireland. Statutory requirement to prepare a Strategy Statement

Under legislation, the Authority is required to prepare a strategy statement every three years. The Authority' first Statement of Strategy was for the period from its establishment in 2016 to end 2018 and the Authority is now developing its strategy for the period to end 2021.

The Act specifies that the Statement of Strategy should:

- include the key objectives, outputs and related strategies of the Authority, including the use of its resources; and
- have regard to the need to ensure the most beneficial and efficient use of the resources of the Authority.

The legislation also allows for the Authority to:

- publish a draft of the strategy statement and allow persons 30 days to make representations in writing to the Authority with regard to it, and
- having considered and made modifications to take account of representations where appropriate, submit the strategy statement to the Minister who is required to lay it before each House of the Oireachtas.

Preparation of the Policing Authority's first Strategy Statement

The Authority is undertaking a strategic planning process to identify and take account of a range of factors relating to its purpose and functions. It has considered the environment in which it operates, its statutory remit and its stakeholders, in particular communities and the citizen. Based on this, the Authority has drafted a strategy statement to guide its work for the next three years and which sets out:

- its objectives for the period 2019 to 2021;
- how it plans to achieve those objectives; and
- how success in achieving its objectives will be measured.

Invitation to make representations

In pursuing our strategic objectives we are committed to serving the interests of citizens and in this context have prepared this strategy in a way that is mindful of the interests of the public and the citizen.

In this context, we are now offering the opportunity to individual citizens and interested organisations to contribute their views on the Statement of Strategy. This offers you an opportunity to contribute your views about the content of the draft and to highlight issues that you consider should be prioritised by the Authority as it builds on its achievements in the first three years since it establishment.
