County Kildare Joint Policing Committee (JPC) aims to develop greater consultation, co-operation and synergy on policing and crime issues between An Garda Síochána, Local Authorities, elected local representatives and relevant agencies. The committee facilitates the participation of the community/voluntary sectors in this regard through its membership profile.

The function of the JPC is set out in section 36(2) of the Garda Síochána Act 2005, which states: “The joint policing committee’s function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of the local authority’s administrative area”.

### **Meetings of County Kildare Joint Policing Committee**

#### **2020 meetings of the committee**

The JPC Committee met three times in 2020 as follows:

1. Monday 2<sup>nd</sup> March 2020
2. Monday 14<sup>th</sup> September 2020
3. Monday 7<sup>th</sup> December 2020

There was no June quarterly meeting due to the initial phase of Covid-19 restrictions.

#### **Policing Reports**

Chief Superintendent John Scanlan and his team presented an overview of the key policing activities for the Kildare Divisions at each of the Kildare JPC Meetings, including quarterly crime analysis, crime prevention and community policing measures, road traffic statistics and details of Garda resources.

The Chief Superintendent and his colleagues responded to questions on the policing reports from members of the committee at each meeting as required.

The issue of Garda resources in County Kildare (*Objective 1 of the 2016-2021 JPC Strategic Plan*) remains an issue of ongoing concern for the JPC members generally. While the roll-out of the new policing model has been affected by Covid-19 restrictions and additional duties, the specific issue of community policing and the number of Gardaí assigned to it was a consistent theme at JPC meetings. Chief Superintendent Scanlon indicated to the members that he considers all Gardaí to be community Gardaí in the first instance and he allocates resources to specific tasks as demands allow.

The problems linked to drug addiction/abuse/supply were also raised frequently, as was the increase in domestic violence, mental health issues and suicides possibly linked to the national public health restrictions. The reported increase of incidents of cybercrime and online bullying was also raised by members frequently.

### **Specific presentations and reports**

In addition to the Policing Reports, the JPC received several presentations and updates in line with the objectives of the JPC's adopted Strategic Plan<sup>1</sup>. This aspect was significantly restricted this year as no external attendees were invited to meetings in 2020.

Draft Drug Litter Clean-Up Protocol	Objectives 3 & 4	Steven Joyce presented the draft protocol which was prepared by the drug litter sub-group of the SWRDATF. The protocol was adopted unanimously.
JPC guidelines & Code of Practice review	All	The committee received a comprehensive review of current implementation of the JPC in Co. Kildare. Members were invited to submit their comments on this review.
Community CCTV	Objective 2	Draft pilot scheme in preparation. Awaiting amending legislation re data sharing.
Divisional Policing Plan 2021	All	JPC members were circulated with details of the plan's preparation and were invited to make submissions as required.

### **CCTV sub-committee**

Co. Kildare JPC has one dedicated sub-committee whose role is to assist with the implementation of Community CCTV schemes as envisaged by the national scheme announced in 2017. The sub-committee is chaired by Cllr. Aoife Breslin. In addition to nominated JPC members, this committee includes relevant Garda personnel and Kildare County Council staff members working in this area.

Kildare County Council has agreed to act as data controller for proposed CCTV feeds. Accordingly, it has prepared a CCTV specification for groups to use to ensure any systems to be installed will be compatible with existing and future traffic management infrastructure. The sub-committee has endorsed this document.

A pilot scheme for Community CCTV is being prepared for Clane. Further development of this scheme is on hold pending clarification of data protection issues which have affected these schemes nationally.

### **Text Alert Working Group**

A small informal working group has been set up to investigate the setting up of a county wide message alert system to replace the numerous stand-alone systems currently in place. It is hoped that a scheme will go to tender in early 2021. Kildare County Council will be required to advertise on the E-tenders platform.

### **An Garda Síochána and Municipal Districts councillors**

Locally based representatives of An Garda Síochána meet with members of each of the five Municipal Districts and the JPC community and agency representatives. These meetings take place on a quarterly basis linked to the formal JPC meetings. This process continued in 2020. Discussions at this local level can and does help eliminate problems such as anti-social behaviour and damage to public property. Councillors will often have access to information that An Garda Síochána may not have or they may be in contact with residents more frequently. Councillors regard these meetings as a vital part of their engagement with An Garda Síochána.

The members of each Municipal District have stressed the importance of these meetings being held without press or public attendance. The members believe that the formats of these meetings are beneficial as they are an informal exchange of essential information at a local level.

The essential role of An Garda Síochána as frontline community support was much in evidence in 2020 and was the source of significant praise from all elected members throughout the year at meetings.

**APPENDIX 2**

**County Kildare Joint Policing Committee Strategic Plan 2016-2021**

The plan was adopted in June 2016. The plan's primary goal is to support safer communities by focusing on nine strategic objectives to support enhanced policing and crime prevention.

These objectives are:

1. Garda resources.
2. Crime prevention – assignment of Gardaí to specialist posts such as Community Gardaí, drugs specialists etc.
3. Anti-social behaviour and street crime.
4. Misuse of drugs, alcohol, and related crime.
5. Wildlife protection and cruelty to animals.
6. To increase public safety of newly designed roads and developments across Kildare – An Garda Síochána and Kildare County Council working in partnership.
7. To liaise with older people in the county through the Older Person's Council.
8. To strengthen the relationship between An Garda Síochána and the local community.
9. To support the local implementation of the National Strategy on Domestic, Sexual and Gender-based Violence.

The Joint Policing Committee aims to develop greater consultation and co-operation on policing and crime issues between the Gardaí, the local authority, community representatives, agencies and elected public representatives.
