#### Address from An Cathaoirleach

As Cathaoirleach of Louth County Council and Chairperson of the Steering Committee of Louth Joint Policing Committee I am pleased to present the Joint Policing Committees Annual Report for 2018.

The report outlines the work and considerations of the Counties three Joint Policing Committees during 2018. The JPC structures are well embedded in the local democratic process and afford us the opportunity as elected members and community representatives, to engage with the practitioners and strategists in the Local Authority and the Garda Síochána in highlighting issues of policing and public safety that are a challenge in our local communities.

The Louth Joint Policing Community Safety Strategy 2016 – 2022 together with the local Policing Plans continue to be the central in structuring the work and reporting protocols of the local committees. The five key themes of the strategy were in 2018 the focus of the committees work in addressing the challenges experienced in communities across the county. Our vision – "Louth will be a county where all of its citizens can lead safe, peaceful lives and experience a good quality of life and well-being" was at the heart of the deliberations of the members during the year and I look forward to it continuing to inform the work of what will be newly constituted policing committees following the local elections in 2019.

Engaging the wider community in the work of the Joint Policing Committees is central to the successful delivery of the Community Safety Strategy objectives. The committee have with the support of the local authority and An Garda Síochána met the statutory requirements in respect of the hosting of Public meetings. This is an area that continues to be a challenge to the work of the committees and despite adopting new initiatives including the extensive use of social media to promote the public meeting programme attendances at these meetings continues to modest.

In concluding I thank the members of the respective Joint Policing Committees for their commitment to this important work and I that the Officials of Louth County Council lead by the Chief Executive and members of An Garda Síochána lead by the Chief Superintendent for their support during the year.

# BACKGROUND AND LEGISLATIVE FRAMEWORK

The Garda Síochána Act 2005 makes provision for the establishment of Joint Policing Committees. The Guidelines issued subsequent to the Act set out to establish the committees based on the experience gained in the pilot areas and on lessons learned from an extensive consultation process commenced in 2007.

The functions of the Joint Policing Committee's are set out in Section 36 (2) of the Garda Síochána Act, which states:

"The joint policing committee's function is to serve as a forum for consultations, Discussions and recommendations on matters affecting the policing of the local authority's administrative area"

- (a) Keep under review—
  - the levels and patterns of crime, disorder and antisocial behaviour in that area (including the patterns and levels of misuse of alcohol and drugs), and
  - (ii) the factors underlying and contributing to the levels of crime, disorder and anti-social behaviour in the area.
- (b) advise the local authority concerned and the Garda Síochána on how they might best perform their functions having regard to the need to do everything feasible to improve the safety and quality of life and to prevent crime, disorder and anti-social behaviour within the area.
- (c) arrange and host public meetings concerning matters affecting the policing of the local authority's administrative area,
- (d) establish, in consultation with the local Garda superintendent, as the committee considers necessary within specific neighbourhoods of the area, local policing fora to discuss and make recommendations to the committee concerning matters that it is to keep under review under paragraph (a) or on which it is to advise under paragraph (b), in so far as those matters affect their neighbourhoods, and
- (e) Co-ordinate the activities of local policing fora established under paragraph (d) or otherwise.

## 1. WORK PROGRAMME & OBJECTIVES COMMUNITY SAFETY STRATEGY

#### Theme 1: Building safer communities

**Goal:** Citizens in County Louth will live safely and peacefully in an inclusive environment and benefit from reduced levels of crime, intimidation, or antisocial behaviour.

### The role of the Joint Policing Committee (JPC): What it can do Strategic Priorities

- 1. Ensure that adequate structures, appropriate representation and sufficient resources are in place to implement a county-wide community safety strategy
- 2. Work collaboratively to reduce serious crime and its impact across the county.
- 3. Reduce the risk of anti-social behaviour in our neighbourhoods, rural communities and town centres, and particularly in PEACE III target areas and other areas of social disadvantage and deprivation.
- 4. Encourage a sense of community capital, ownership and civic participation in communities across the county with an emphasis on PEACE III target groups, non-Irish nationals and other ethnic minorities.

#### Theme 2: Tackling alcohol and substance misuse

Goal: We will work with existing agencies and their partners to reduce the impact of alcohol, substance misuse and drug-related crime on communities in Co Louth

#### **Strategic Priorities**

- 1 Consideration should be given in a revised JPC structure to reflect representation of the NERDATF, members of the Louth Drugs & Alcohol Forum and statutory and community and voluntary sector partners in County Louth.
- 2 Develop a county-wide substance misuse and detoxification strategies in collaboration with other statutory organisations.

#### Theme 3: Nurturing children and young people

**Goal**: Children and young people will lead fulfilled lives in safe, peaceful and confident communities.

#### **Strategic Priorities**

- 1 Work in partnership to ensure that young people engage positively with the justice system.
- 2 Support the provision of safe, friendly, alcohol and drug-free recreational spaces with adequate facilities and appropriate opening times, where children and young people can gather in an inclusive, safe and positive way.

#### Theme 4: Supporting older and vulnerable people

**Goal:** Older and vulnerable people will feel respected and safe within their communities and enabled to access necessary services.

#### **Strategic Priorities**

- 1 Support the implementation of the Louth Age Friendly strategy.
- 2 Continue to implement An Garda Síochána's Older People's safety strategy in collaboration with the relevant partners.

#### Theme 5: Encouraging integrated communities

**Goal:** We will foster and support peaceful and safe community co-existence, where new and existing residents adapt to one another and to their local areas, within a shared set of values and purpose.

#### **Strategic Priorities**

- 1 Work in partnership in a systemic way to build a peaceful, safe, inclusive and cohesive society that is tolerant and respectful of diversity.
- 2 Ensure that there is adequate representation of ethnic minority groupings and other PEACE III target groups within the JPC structure.
- 3 Continue to build cultural and attitudinal change through working with the relevant agencies to sustain the PEACE III initiatives and programmes where appropriate.

#### 2. COMMITTEE BUSINESS

Garda & Local Authority reports to the committee meetings continue to be presented to reflect the aims and goals of the respective Policing Plans and Community Safety Strategy. This format provides a statistical basis to any developing trends.

Members of the Committees actively debate and discuss with senior Local Authority and Garda Officials issues that are specific to the Municipal District Areas and more general crime challenges faced by communities across the county. The key issues raised in the year reported are set out below.

Senior Gardaí and Local Authority officials have been proactive in ensuring that staff dealing with specific issues, are available to the JPC members. The attendance of such members has had a positive impact on the engagement with the committees, resulting in more wholesome and informed debate.

Recommendation from the committee in respect of distractive type events at Halloween and Bonfire Night have proven effective in reducing the number of anti-social behaviour incidents. The local knowledge and awareness of the challenges faced by local communities has assisted in informing responses and pro-active actions by both the local authority and An Garda Síochána.

#### 3. Joint Policing Committee Public Meetings

The committee have with the support of the local authority and An Garda Síochána met the statutory requirements in respect of the hosting of Public meetings. This is an important element in the work of Joint Policing Committees. Encouraging attendance at public meetings continues to be a challenge with committees having mixed success in regard to the numbers of members of the public attending these meetings. New initiatives were adopted in 2018 which included the extensive use of social media to promote the attendance at public meetings. Local Authority and Garda networks were also used to encourage attendance and engagement with the Committees. While there was some improvements further work is required to ensure the Public meeting schedule is more effective in reaching out to communities.
