#### Introduction

The Annual report 2021 sets out how the County Mayo Joint Policing Committee carried out its functions for this period in accordance with Section 36(2) of the Garda Síochána Act 2005 and in accordance with the revised Joint Policing Committee Guidelines 2014.

#### **Role of the Joint Policing Committee**

The legislative framework for the establishment of Joint Policing Committees is set out in Section 36(2) of the Garda Síochána Act 2005.

Section 36(2) provides that the Joint Policing Committee is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of the local authority's administrative area. The Act refers specifically to the following matters:

- Keep under review
- (a) the levels and patterns of crime, disorder and anti-social behaviour (including the patterns and levels of misuse of alcohol and drugs) and
- (b) the underlying factors that contribute to these issues.
- Advise the local authority and the Garda Síochána on how they might best perform their functions and do everything feasibly possible to improve the safety and quality of life, to prevent crime, disorder and anti-social behaviour.
- Arrange and host public meetings concerning matters affecting the policing of the local authorities' administrative area.
- Establish in consultation with the local Garda Superintendent and specific neighbourhoods, local policing fora to discuss and make recommendations to the JPC.
- Co-ordinate the activities of local policing fora.





The Mayo Joint Policing Committee (JPC) was established in 2009 under the Garda Síochána Act 2005. The overall aim of the JPC is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of Mayo County Council's administrative area. The JPC also review levels and patterns of crime, disorder and anti-social behaviour and the factors contributing to such crime.

#### GARDA REPORT:

On December 20, 2020 the Mayo Garda Division expanded its Divisional Drugs Taskforce, and since the 1<sup>st</sup> of January 2020, **€2,196,109.68** worth of drugs have been seized, approximately €30,000 worth of counterfeit currency has been removed from circulation, and more than €136,800 in cash has been seized in Co Mayo.

Included in these seizures is the detection of five grow houses ranging in value from €10,000 to €432,000, which have been significant in disrupting the sale and supply of drugs in the Mayo Garda Division.

Mayo is operating to the new divisional policing model and the model has enabled the provision of more resources by the Divisional Officer, Raymond Mc Mahon, to tackle the sale and supply of drugs.

The policing model has created greater flexibility and has allowed us to take a county wide view of crime rather than a District focus. The new model has also enabled the expansion of the Divisional Drugs Taskforce, which now consists of two sergeants and seven Gardaí.

Two additional members from uniform personnel are seconded to the Divisional Drugs Taskforce each three-month period.

## Item 2: Please highlight three key achievements of the JPC during the year and give reasons why they are significant.

#### Achievement 1:

Sgt Paul Maher gave a presentation of the Search and Rescue app and the Mobility app to the JPC meeting in September.

#### Achievement 2:

The establishment of sub-committees was discussed, and it was agreed to go ahead with the setting up of the following sub-committees -:

- 1. Community Engagement
- 2. Traffic and Road Safety
- 3. Crime and Drugs
- 4. Public Order and Anti-Social Behaviour

Members of these sub-committees will comprise of members of the JPC, AGS and other relevant agencies. The sub-committee's will be aligned with the objectives of the new Strategic Plan; and tasked with delivering actions outlined in same. An update report from the sub-committee's will be included as an item on the JPC agenda.

#### Achievement 3:

#### The establishment of Swinford Local Policing Forum

The statutory basis for the formation of Local Policing Fora is set out in section 36(2) (d) of the Garda Síochána Act 2005. The JPC must:

(d) establish, in consultation with the local Garda superintendent, as the committee considers necessary within specific neighbourhoods of the area, local policing fora to discuss and make recommendations to the committee concerning matters that it is to keep under review under paragraph (a) or on which it is to advise under paragraph (b), in so far as those matters affect their neighbourhoods, and

(e) co-ordinate the activities of local policing fora established under paragraph (d) or otherwise."

The fora provide a mechanism through which the community, Gardaí and Mayo County Council can come together in a formal structured way with the community to consider issues of community safety.

The forum was set-up in January 2021 and is chaired by Cllr. Neil Cruise.





#### The establishment of Swinford Local Policing Forum (cont.)

Topics of concern in Swinford for the group are:

- The requirement for a Family Resource Centre in Swinford and process involved in establishing same.
- The provision for CCTV in Swinford
- Anti- Social Behaviour
- Housing issue's

The group meets in advance of each JPC and an update of same is included in Supt. Gabriel Moran's report for the Claremorris / Swinford Area.
