Introduction

This Annual report 2022 sets out how the County Mayo Joint Policing Committee carried out its functions for this period in accordance with Section 36(2) of the Garda Síochána Act 2005 and in accordance with the revised Joint Policing Committee Guidelines 2014.

Role of the Joint Policing Committee

The legislative framework for the establishment of Joint Policing Committees is set out in Section 36(2) of the Garda Síochána Act 2005.

Section 36(2) provides that the Joint Policing Committee is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of the local authority's administrative area. The Act refers specifically to the following matters:

- Keep under review
- (a) the levels and patterns of crime, disorder and anti-social behaviour (including the patterns and levels of misuse of alcohol and drugs) and
- (b) the underlying factors that contribute to these issues.
- Advise the local authority and the Garda Síochána on how they might best perform their functions and do everything feasibly possible to improve the safety and quality of life, to prevent crime, disorder and anti-social behaviour.
- Arrange and host public meetings concerning matters affecting the policing of the local authorities' administrative area.
- Establish in consultation with the local Garda Superintendent and specific neighbourhoods, local policing fora to discuss and make recommendations to the JPC.
- Co-ordinate the activities of local policing fora.

The Mayo Joint Policing Committee (JPC) was established in 2009 under the Garda Síochána Act 2005. The overall aim of the JPC is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of Mayo County Council's administrative area. The JPC also review levels and patterns of crime, disorder and anti-social behaviour and the factors contributing to such crime.





Steering Committee

The Mayo JPC Steering Committee consists of the chairperson of the JPC, a representative of An Garda Síochána and the Chief Executive of the local authority or a person nominated by him or her. The function of the steering group is to facilitate the efficient functioning of the JPC and to ensure that it retains a clear focus on strategic and collaborative action. It will also arrange procedures for the appointment of any new or replacement members, draw up the agenda and arrange documentation for meetings, be the point of contact for co-operation and joint action with other JPCs and with any subcommittees of the JPC.

GARDA REPORT:

On December 20, 2020 the Mayo Area of Mayo/Roscommon/Longford Garda Division expanded its Divisional Drugs Taskforce, and since the 1st of January 2020, **€2,561,353.97** worth of drugs have been seized, approximately €30,000 worth of counterfeit currency has been removed from circulation, and more than €177,884 in cash has been seized in Co Mayo.

Included in these seizures is the detection of five grow houses ranging in value from €10,000 to €432,000, which have been significant in disrupting the sale and supply of drugs in the Mayo Area of Mayo/Roscommon/Longford Garda Division.

Mayo is operating to the new divisional policing model and the model has enabled the provision of more resources by the Divisional Officer, Raymond Mc Mahon, to tackle the sale and supply of drugs.

The policing model has created greater flexibility and has allowed us to take a county wide view of crime rather than a District focus. The new model has also enabled the expansion of the Divisional Drugs Taskforce, which now consists of two sergeants and seven Gardaí.

Two additional members from uniform personnel are seconded to the Divisional Drugs Taskforce each three-month period.

Achievement 1:

At the March JPC meeting Siobhán McBrearty from the HSE, Mayo Suicide Prevention Alliance (MSPA) gave a presentation on "Connect for Life" - Ireland's National Strategy to Reduce Suicide.

The focus of the presentation was on Goal 6 of strategy, i.e. - "Reduce Access to Means", to reduce and restrict access to means of suicidal behaviour.

Achievement 3:

Following a request to Deputy Commissioner Shawna Coxon to outline the proposal around the restructuring of JPC's, Ben Ryan, Department of Justice, gave a detailed presentation on the new Local Community Safety Partnerships to the JPC.

Ben Ryan acknowledged the good work of JPC's and reminded members that this is a pilot scheme. The assessment and evaluation from it will feed into legislation. He agreed that one size does not fit all but geographical size was taken into consideration when choosing the three pilot areas.

The structure of the new Local Community Safety Partnerships mirrors other for a such as LCDC's as it was felt that today's issues cannot be solved by AGS alone, input from other agencies, e.g. emergency services, HSE, Tusla etc. is required.

The purpose of the pilot is not to diminish the role of Councillors but to increase the role of a wider community of businesses, services and the public. There is a community innovation safety fund with a budget of €2 million available for innovative projects.

There would be one new forum per Local Authority and in the pilot regions of Waterford, Longford and North Inner-City Dublin the JPC's have been replaced.
