2. Actions and matters of Note

- 2.1. The minutes from the Committee meeting of 7 March 2016 were agreed and signed by the chair.
- 2.2 The Garda representatives provided a brief on the process they conducted in preparing the previous draft Code of Ethics, including detail in relation to the steps taken to consult in relation to the draft Code. The chair thanked the Garda representatives for the very useful background information. Following the presentation there was a full discussion with Garda representatives exploring a range of relevant issues and challenges.
- 2.3 The Executive confirmed that the consultation paper was issued on Thursday 7 April and provided an update to the Committee on the steps that were taken to publicise the paper. The responses that have been received so far were brought to the attention of the Committee.
- 2.4 An update was provided to the Committee by the Executive on the proposed next steps to be taken in preparing the draft code. It was agreed that the Executive would provide a briefing to the Committee on a summary of the underlying themes referred to in other policing codes of Ethics and other professions at the next meeting.
- 2.5 The updated timeline mapping out steps that need to be taken provided by the Executive to the Committee was discussed. The Committee agreed that it would beneficial to hold an open public forum in September to facilitate consultation.
- 2.6 There was a discussion about whether "speaking up" should be required or encouraged. It was agreed that this matter would be revisited.
- 2.7 The meetings dates for the rest of 2016 were agreed to as: 14 July at 2pm, 1 Sept at 10am, 11 Oct at 10am, 8 Nov at 10am and 5 Dec at 10am.
