Both programmes are delivered via a collaborative approach, involving a large number of stakeholders and agencies. The DPYDA grew from a JPC initiative, and the NASA programme uses the relationships built through the DPYDA programme to deliver practical interventions on the ground.

Funding accessed from the CLAR programme for Emergency Response groups in the county, helping us to strengthen the network of defibrillators and first responders in remote parts of the county

The inadequate number of in-patient places for addiction treatment programmes in the county was raised. Given the amount of misery caused by alcohol and drug misuse, and the financial cost to the Exchequer each year, the JPC feels that treatment facilities would be a wise investment.

ITEM 2 – Highlight 3 key achievements of the JPC during the year & explain why they are considered to be significant

Much effort was put into seeking a way to facilitate the migration of all existing Community Text Alert groups across to Monaghan County Council's online Monaghan Alert service, which allows anyone living in Monaghan to register their email or mobile phone number to receive alerts on issues affecting them such as road closures, severe weather alerts, flood warnings etc.

We hope that the system offers a solution to the issue of having parts of the county not covered by any Community Alert group, as individuals from any part of the county are free to sign up directly to the service. It also offers a solution to local groups, as once the person signs up once, they never have to be re-signed, and the Council is bearing the cost of the texts rather than the individual, so groups didn't have to go around collecting annual subscriptions. The Gardai also like the concept, as it is all done online, and one message can be issued to the whole county or narrowed down to within a certain km radius of a given location.

However, there are some contractual issues to be sorted with the service provider before the project can proceed. We are hopeful of concluding this project in 2018.

The Property Marking Scheme promises to be a game changer in the fight against rural crime. The scheme is simple: it operates by stamping a householder's postcode into any valuables they wish to have marked. The householder then displays posters at the entrance of their property to deter would-be thieves from targeting goods on the premises, as marked goods will be more difficult to sell on. Once a community group has carried out marking events at 50 households in their area, the Council will erect 'Property Marking Scheme in Operation in this Area' signage, similar to 'Community Alert Area' signage schemes.

The Scheme was put together by An Garda Síochána, who then brought it to the Community Dept of the Council, to find a way to roll it out into every community in the county. The Council had set up a network of Community Alert groups, on the recommendation of the JPC, and will be using this to roll out the initiative.

A number of Council staff will be trained to instruct community leaders in operating the machine. The machine will then be lent out around areas, with local groups organising property marking events. This will be the first county-wide property marking initiative in the country. The Council has already written to the Dept of Community & Rural Affairs to suggest that 'Response to Rural Crime' be added to any new CLAR programme, so that other counties might follow suit.

Cavan Monaghan Garda Division has set up a Facebook page, and have been getting great engagement with the public through it. They have been using it to promote road safety campaigns, etc. The Page was particularly successful in supporting the NASA campaign and the Don't Pour Your Dreams Away campaign, on one occasion showing a photo of the results of Garda searches of a bus on its way to a teen disco in Monaghan town. The message that alcohol will not be tolerated on buses was sent out loud and clear, and there have been no repeat incidents.

ITEM 3 -Details of public meetings held during the year

There were no public meetings held during 2017.

Due to disappointing attendances at past JPC public meetings, the JPC has decided to innovate with future public events. In order to achieve maximum engagement by the public in the JPC's meetings, the JPC will join up with Monaghan County Council's Public Participation Network, which has a database of over 400 community groups and runs well-attended, 4 county-wide plenary meetings per year. We are proposing that instead of trying to get a small group to come out to a policing-only themed meeting, we instead will host a table at PPN plenary events, at which policing issues can be discussed and debated.
