Annual Report of Monaghan Joint Policing Committee for year: 2021

Overview

2021 was once again a difficult year in which to carry out the work of the JPC, as the Covid pandemic made coming together to meet difficult. However, we persevered, and by hiring a large theatre as a venue for our committee meetings, were able to achieve some semblance of normality whilst observing social distancing rules.

Naturally, the public meeting element of our workplan was again unachievable due to Covid restrictions. But overall, we were able to keep an active schedule of work and retain a high profile in the local press, for which we are grateful.

Projects

The JPC continued to run the following initiatives during 2021:

Property Marking:

As community groups were not able to organise local events due to covid restrictions, An Garda Síochana stepped up and made use of their new Community Policing Units to get out and about with the property marking machine, marking for businesses around the county. The JPC organised public events in each of the five towns during the summer months, with communities providing a suitable venue such as a car park, and the local authority arranging crowd control with barriers etc to ensure social distancing, whilst An Garda Siochana carried out the property marking.



Monaghan Community Alerts:

The county-wide community alert scheme now has over 4,800 users. The Gardai sent out 160 messages through the service, which is now in its third year.

The scheme continues to have success in combating rural crime. In one case, an alert put out via the app to keep a look out for a distinctive trailer not only caused the trailer to be abandoned on the roadside, but resulted in a subscriber identifying the trailer as being missing and phoning in its location to the gardai.

CCTV Steering Committee

The CCTV Committee is still awaiting the outcome of an application made in 2020 to the Garda Commissioner for a new CCTV scheme for Monaghan town. Work is progressing on a submission for a CCTV scheme for Carrickmacross. A public consultation event is planned for early 2022.

ITEM 2 – Highlight 3 key achievements of the JPC during the year & explain why they are considered to be significant

Continuing to meet on a regular schedule was an achievement in and of itself during 2021!

Much of the significant action took place 'off the pitch' this year. For An Garda Siochana, it was a year of change, with the introduction of Community Policing Units and the Garda Divisional Protective Services Units. The Community Policing Units have been working closely with Council staff, particularly on facilitating the delivery of a service to vulnerable members of the public through the Community Call helpline. While this work was not directed through the JPC, the closer connections forged between Council and Gardai in the process of working together on the Community Call initiative will no doubt pay dividends for the JPC going forward.

The Garda Victim Services Office made a presentation to the JPC on their work during 2021. Already, the work of the Office is having an impact on the crime statistics for the county, with the number of crimes being reported increasing – showing an increasing confidence amongst victims of crime in the justice system and in how they will be treated as their complaint is pursued.

The JPC has been monitoring the level of diesel laundering in the county since its establishment. It welcomed the introduction of biological markers by Customs a few years ago, which saw a marked reduction in the number of incidents of diesel wash dumping in the county. However, 2021 has seen these incidents begin to rise again. It would appear that the fuel laundering industry has caught up with the technology and is now able to counteract the biomarkers.

The JPC's taking note of the increase in the levels of diesel wash and alerting Customs to the need to update their technology may save the Exchequer millions of Euro in lost revenue, as well as prevent a potential environmental catastrophe somewhere in Co. Monaghan.
