Message from the Chairperson of Co. Monaghan Joint Policing Committee

As Chairperson of the Co. Monaghan Joint Policing Committee (JPC), I welcome the publication of the Joint Policing Committee's Annual Report for 2023. The Report details the work that the Committee has undertaken throughout the year, and it is an important means of communicating the role and work of the Committee.

Throughout the past year, the Joint Policing Committee continued to play a valuable role in providing strategic linkages and strong channels of communication between An Garda Síochána, Monaghan County Council and the wider community in matters of policing and safety. The JPC provides a level of local democratic oversight of the Gardai's work within the County. It provides a forum for the elected members, community representatives and voluntary organisations to raise matters of concern in their areas.

The JPC is intended to be a forum for discussion and a means of building confidence, trust and safety in the county. In doing this, the JPC seeks to prioritise key community policing policy issues and identify initiatives which will contribute to improved community policing and prevention or reduction of future crime in Monaghan County.

County Monaghan Joint Policing Committee held four meetings during 2023, including 1 public meeting.

I would like to acknowledge the excellent level of participation by the elected and community representatives on the committee and to each member of the committee for their continuing support in fulfilling the role and purpose of the Joint Policing Committee. I also wish to thank the Gardai for their cooperation and openness with the committee and to Monaghan County Council staff for their administrative support.

Finally, I would like to sincerely thank the local press who attend all our meetings and continue to be a powerful ally in getting our message out to the public.

Background and legislative framework

The County Monaghan Joint Policing Committee was first established in 2009. It is made up of representatives from Monaghan County Council (elected members and officials), members of the Oireachtas in the county, An Garda Síochána and the Community and Voluntary sector.

The functions of the Joint Policing Committees are set out in Section 36 (2) of the Garda Síochána Act, which states: 'The joint policing committee's function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of the local authority's administrative area'.

The Annual Report for 2023 outlines how County Monaghan Joint Policing Committee carried out its function for this period in compliance with section 36(2) of the Garda Síochána Act 2005 and in accordance with the revised Joint Policing Committee guidelines.

The JPC continued to run the following initiatives during 2023:

Property Marking

Monaghan County Council was the first local authority in the country to set up this initiative; it is now running in every local authority in Ireland. An Garda Síochána, through their Community Policing Units, continued to carry out property marking events, marking for businesses around the county, throughout the year.

Community Alerts

Another first for Monaghan - the country's first county-wide text alert initiative. In early 2023, the JPC migrated the service across to Monaghan County Council's platform, where it has been amalgamated with the Council's existing alert service. This enhanced 'Monaghan Alerts' service now provides a one-stop-shop for weather alerts, Council alerts and Garda alerts. Users can receive alerts by text, email or app. The service is being funded by Monaghan County Council. Gardai can issue alerts to one or more local community area, or to the whole county.

RACE anti-racism toolkit

During 2023, work has continued on the production of the activities and support material which is to go into the schools anti-racism toolkit, for which funding was secured in 2022 from the Community Safety Innovation Fund. It is intended to complete the design and production of the toolkits in early 2024, so that they can be launched by the JPC before it is dissolved in preparation for the next Local Election.

It is intended to involve Transition Year students from all the secondary schools in the county in peer education training in September 2024 so that they can then deliver anti racism activities and workshops in their communities.

Key achievements of the JPC during 2023:

Largy College's Young Social Innovators 2021 class's RACE project

Largy College's Transition Year students visited the JPC to present their award-winning anti-racism work and ask the JPC to assist in keeping the work alive after the students move on. The JPC agreed to adopt the students' project, called RACE, and to work toward developing it into a toolkit which could be used to deliver anti-racism awareness workshops in schools throughout the county.

The toolkit is now at an advanced stage of development and will be launched in spring 2024.

Community Safety Innovation Funding

The Community Safety Innovation Fund funding which is covering the cost of developing the antiracism toolkit also covered the cost of holding a Community Safety Seminar which focused on Women's Safety. This was organised to coincide with the 11 Days of Activism Against Violence against Women, which took place in December. Speakers included the CEO of Safe Ireland, a landscape designer who spoke about designing safe public spaces, and Monaghan County Council's senior horticulturalist, who presented a project that he carried out with the students from St Louis Secondary school on making Monaghan Greenway safer for women and girls.

Public Meeting held on Thursday 23 November 2023

To honour the United Nations' global 16 Days of Activism Against Violence Against Women campaign, the theme of our public meeting was 'Improving Women's Safety'.
