Annual Report 2016

The Sligo Joint Policing Committee (JPC) was re-established in 2015 under the Garda Siochána Act 2005 and in accordance with the Joint Policing Committee Guidelines as amended in August 2014. The overall aim is to serve as a forum for consultations, discussions and recommendations on matters effecting the policing of Sligo County Council's administrative area and to keep under review the levels and patterns of, and the factors underlying and contributing to the levels of crime, disorder and anti-social behaviour in the area.

Steering Group

Each JPC must establish a steering group, consisting of the Chairperson of the JPC, a representative of An Garda Síochána, and the Chief Executive of the Local Authority or a person nominated by him or her. The function of the steering group is to facilitate the efficient functioning of the JPC and in particular to ensure that it retains a clear focus on strategic and collaborative action. It also arranges procedures for the appointment of any new or replacement members, draws up the agenda and arranges for documentation for meetings, and is the point of contact for co-operation and joint action with other JPC's and with any subcommittees of the JPC. Activities of the Committee & Steering Group

At its inaugural meeting held on 18/12/15, the following business was attended to by the Committee:

- appointment of JPC Chairperson
- appointment of JPC Vice Chairperson
- presentation by Sergeant Pat Conway, Garda National JPC Committees Monitoring Office, Community Relations and Community Policing on the JPC Guidelines
- presentation by Ms Therese Hogg, Blue Zebra (who undertook Cross Border research studies in 2014, under Peace 111 Programme into policing and community safety)
- adoption of Standing Orders
- agreed to initiate development of Strategic Plan and Work Plan via the Steering Group

Meetings of the Sligo Joint Policing Committee Steering Group took place on 19th January, 2016 and 23rd November, 2016. Business conducted related primarily to the development of a Draft Six Year Strategic Plan for the consideration of the JPC, which was signed off by the Steering Group at its meeting on 23/11/16.

The Joint Policing Committee met on Friday 16th December, 2016, the main business which took place was the consideration of the Draft six year Strategic Plan, also a presentation was made to the Committee by Mr. Sean O'Connor, Northwest Regional Drug & Alcohol Task Force (NWRDATF) Co-ordinator.

Draft Strategic Plan 2017 -2022

A presentation on the draft Strategic Plan, as recommended by the Steering Group, was made to the members of the Joint Policing Committee at its meeting on 16/12/16, which addressed:

- Overview of Revised JPC Guidelines
- Demographics of County Sligo
- Crime Trends in Sligo District
- Mission Statement
- Strategic Priorities
- Monitoring & Evaluation

The Draft Plan identified five strategic Priority areas for actions:

- Crime Prevention
- Community Policing
- Road Safety
- Public Safety
- Communication & Promotion of JPC

Key objectives were identified under each of the priority areas, to be delivered over the life-time of the Plan. It also identified lead agencies and key partners in respect of each of the deliverables, to be over-seen by the Joint Policing Committee.

The members of the JPC agreed on the following priorities / actions for inclusion in the Draft Strategic Plan:
