### Introduction

Section 35 of An Garda Síochána Act 2005 provides for the establishment of Joint Policing Committees (JPC).

The Tipperary Joint Policing Committee was established in 2014 following the merger of North and South Tipperary County Councils and the abolition of North Tipperary JPC and South Tipperary JPC.

The Joint Policing Committee's function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of the Local Authorities administrative area.

### Presentations to the JPC 2021

In addition to strategy development work, the JPC also received presentations and considered other relevant policing matters.

At each meeting Chief Superintendent Derek Smart provides the committee with an update on the levels and patterns of crime, disorder and anti-social behaviour in the county.

At the February meeting (11/2/2021) Fiona Crotty gave a presentation on Tipperary Age Friendly Digital Connections which is aimed at promoting digital technology and engagement among older people in Tipperary with pilot sites across the County.

At the May meeting (14/5/2021) Anne Bradshaw HSE gave a presentation on the 'Inside Out' booklet. The aim of the booklet is to make society a safer place for all.

Inside Out came about as a result of increasing concern amongst people with disabilities and older people in the community who have been victims of crimes or are fearful of becoming crime victims in their local community. The aim was to create a project that would highlight the issues but also provide a solution or project that would bring about a change in society. Long term impact of crime on people with disabilities and older people is sometimes underestimated. In November of 2021 the project was honoured in the 2021 Garda Síochána Youth Awards.

## **Membership of County Tipperary Joint Policing Committee**

The membership of the Tipperary Joint Policing Committee is based on the Joint Policing Committees Guidelines – Amended August 2014. Tipperary County Council has 40 elected members. It is recommended that the JPC consist of:

2 An Garda Síochána,15 Local Authority Elected Members,





- 5 Oireachtas Elected Members,
- 9 Community
- 2 Local Authority Officials

At the July 3<sup>rd</sup> 2020 meeting Tipperary JPC agreed to add an extra member to the Committee to represent migrant community. This was proposed by Cllr Pat English and seconded by Cllr Marie Murphy. On the 20<sup>th</sup> of December 2021 Tipperary PPN elected Sabelo Mavuso as the Migrant Rep to Tipperary JPC. This increases the membership of the PPN from 32 to 33.

## **Key Achievements of Tipperary JPC in 2021**

- Four meeting held in 2021 all using zoom due to Covid 19 restrictions.
- Presentations in relation to the review of levels and patterns of crime, disorder and anti-social behaviour in Co Tipperary were provided at all the JPC meetings and clarity in relation to key Garda Operations and Policies were provided across a range of areas.
- Two external presentations one on digital poverty and the second on crime and disability
- Tipperary PPN elected Sabelo Mavuso to Tipperary JPC as a migrant representative
- A number of Tipperary JPC members attended Drug Intimidation Reporting Programme Training on 25th February 2021.
- Tipperary JPC funded and organised property marking events in Cappawhite, Drangan and Nenagh (X2) for community groups. There is one more being held in Newcastle on Jan 2022. Full list of groups who attended are in Appendix 1.
- Tipperary JPC took possession of the property marking machine from Property Marking Ireland.
- Tipperary JPC, received a Joint Data Controller Document which must now be completed by Tipperary County Council for all CCTV Scheme applications for Garda Commissioners Authorisation under Section 38(3)(c) of the Garda Siochana Act 2005.
- Tipperary JPC began the application process for Garda Commissioners Authorisation under Section 38(3)(c) of the Garda Siochana Act 2005 for the following Community CCTV Schemes

- Tipperary JPC sought and received comment from Tipperary County Council Planning Section in relation to CCTV developments in Borrisokane and Roscrea
- Tipperary JPC supported the development of the migrant integration strategy and the survey link was sent to all the Garda District. A Garda was nominated to the Migrant Interagency group. Actions that the Gardai are interested in progressing include recruitment of non-Irish nationals to the force, tackling domestic violence and coercion in the non-Irish Community and communicating the ethos of Irish Policing to those from other cultures.

- Tipperary JPC sought advice from Tipperary County Council Data Protection Officer in relation to Joint Data controller Document and the DPIAs
- Tipperary Agri Co-ops and An Garda Siochána distributed Resilient Packs to older adult farmers who traditional would not be involved in older adult community groups and who may not typically engage online to get their information groups.
