#### Chair and Vice Chair.

#### **Operating Guidelines**

Revised Guidelines for Joint Policing Committees issued by the Department of Justice and Equality, dated the 29<sup>th</sup> August, 2014 were circulated to the committee and the following requirements were noted:-

- 1. The committee will operate at County level, following the abolition of the 4 Town Councils
- 2. The preparation of a six year Strategic Work Plan
- 3. The preparation of annual work plans
- 4. The submission of an Annual Report (no later than 3 months after the end of each year).
- 5. The requirement to put in place a communications strategy

#### Establishment of the JPC Steering Group

The JPC steering group is established comprising, Councillor Jim Ruttle, Chair, Chief Superintendent John P. Quirke and Lorraine Gallagher, Senior Executive Officer, Wicklow County Council (Chief Executive's nominee).

# Wicklow County Council Joint Policing committee Six Year Strategic Plan 2016-2021

Wicklow County Council adopted the WCC Joint Policing Committee Six Year Strategic plan, 2016 - 2021 at Council meeting held on the 3<sup>rd</sup> of October, 2016 which was formally launched at a public meeting held in Roundwood on the evening of the 2<sup>nd</sup> of November, 2016. The Plan was prepared to enable the Joint Policing Committee take a genuine strategic and collaborative approach to policing issues in County Wicklow and to strengthen the strategic alignment of JPCs with other relevant County Plans and structures.

The Four key themes identified within the Plan, following wide stakeholder consultation and which will continue to inform the key objectives for the JPC's annual work plan for 2018 are:

- (1) Policing Communities
- (2) Tackling Crime in Rural Areas;
- (3) Drug Prevention
- (4) Communications.

<u>The Wicklow County Council Joint Policing Committee Work Plan</u> The JPC Work Plan, 2018 is contained within the 6 Year Strategic Plan and set out hereunder within this report.

#### Working groups to advance the activities of the JPC

Four working groups have been set up to advance the activities of the JPC and roll out the agreed four key areas within the Plan. This structure was identified as a step to achieve successful implementation of the 6 year Strategic Plan. Each working group has appointed a Chair to oversee the work of the committee and is supported by An Garda Siochana, representatives from Wicklow County Council. Contributions from the community sector and local stakeholder agencies is key to the success of the groups in implementing and reporting on the annual work plans

# ITEM 2. – Highlight three key achievements of the JPC during the year and give reasons why these are considered to be significant

#### 1. CCTV for Blessington

In December, 2018, the Wicklow County Council Joint Policing Committee approved the application for the provision of CCTV system for Blessington. The key objectives of the scheme are to enhance existing policing provision within the community, to assist in the prevention and reduction of local crime, disorder and anti-social activity and to increase community involvement in the provision of legitimate, integrated responses to prevent and reduce crime in local areas in association with appropriate areas.

#### 2. Operation of four working groups to implement objectives of the 6 year plan

Working groups have been set up to implement the objectives of the Wicklow County Council Joint Policing 6 year Plan under the 4 key areas identified:

- (1) Policing Communities
- (2) Tackling Crime in Rural Areas;
- (3) Drug Prevention
- (4) Communications.

These groups meet approximately 3/4 times are year. Each committee has a Chair and the administrative support is provided by an official of Wicklow County Council. The committee is supported by representatives from An Garda Siochana and comprise representatives from the elected members and community groups. The committees are open to contributions from local stake holders outside of the JPC such as Muintir na Tire, The uplands Council and the Local Drugs and Alcohol Task Force.

### 3. Holding of public meetings

The value of public meetings organised by the Wicklow County Council Joint Policing Committees cannot be underestimated. The holding of public meetings by the JPC in various locations throughout County Wicklow are seen as key to bringing the work of the committee closer to the community. A public meeting of the JPC was held in Arklow on the 18<sup>th</sup> of April, 2018 and in Rathdrum on the 24<sup>th</sup> of October, 2018. Both meetings were attended by members of the community and local stakeholder organisations. The Superintendent for the respective areas made a power point presentation on relevant matters and among the issues raised and discussed were: Illegal substances, instances of illegal dumping, incidents of attacks by roaming dogs, weekend cyclists and dangers presenting, alert alarms for older people living on their own, crimes in rural areas and speeding cars.

### An Garda Siochana Youth Awards 2018

The Wicklow Garda Youth awards is now in its fourth year. This initiative recognises the great work being carried out by young people in many communities throughout County Wicklow and is something that An Garda Siochana wishes to acknowledge, recognise and reward through the Garda Youth Awards. The 2018 awards took place in the Park View Hotel in Newtown, Co. Wicklow on the 8<sup>th</sup> of March, 2019 and are sponsored by the Wicklow County Partnership and is identified in the 6 year Strategic Plan as a strategic priority objective.

The Wicklow County Council Joint Policing Committee congratulates An Garda Siochana for this fantastic initiative and looks forward to its continued success into the future.

**Older Persons National Convention at Druids Glen:** The National Older Persons convention was held in the Druids Glen Hotel on the 8<sup>th</sup> and 9<sup>th</sup> of November, 2018. 5 delegates from each county were represented including the Chair of the Older Persons Council (OPC) the County Age Friendly programme manager and 3 members of the OPC. On the morning of the 8<sup>th</sup> there were information stands which included representation from An Garda Siochana. The event was extremely successful and hugely supported.
