#### Background:

The Wicklow County Council Joint Policing Committee (JPC) was established in 2007 as part of the initial pilot phase along with a JPC in each of the Town Council areas of Bray, Arklow, Greystones and Wicklow. Following the abolition of the Town Councils in 2014 there is now one statutory policing committee being the Wicklow County Council Joint Policing Committee.

**Membership:** Membership comprises 15 Local Authority Elected Members (3 from each municipal District), 5 Oireachtas Members representing County Wicklow, 7 Community Representatives drawn from the PPN, 2 members of An Garda Siochana (The Chief Superintendent for the area and his/her nominee), 2 Local Authority Officials (The Chief Executive and his nominee). The Cathaoirleach of Wicklow County Council is an ex-officio member.

#### **Chair and Vice Chair:**

The Wicklow County Council Joint Policing committee was reconstituted following the local elections in May, 2019. At the inaugural meeting of the newly reestablished committee Cllr. Gerry Walsh was elected as the Chair and Councillor Irene Winters the vice chair.

#### **Operating Guidelines:**

The JPC operates in accordance with the revised guidelines for Joint Policing Committees issued by the Department of Justice and Equality, dated the 29<sup>th</sup> August, 2014, superceded by the Guidelines for Joint Policing Committees issued in 2022 by the Policing Authority.

#### JPC Steering Group:

The JPC steering group is established comprising, Councillor Gerry Walsh, Chair, Chief Superintendent Anthony Pettit, Chief Executive Brian Gleeson and/or Lorraine Gallagher, Director of Services, Wicklow County Council (Chief Executive's nominee).

**Purpose of the JPC**: The JPC provides a forum where the LA public representatives, and senior Garda officers, responsible for the policing of County Wicklow, with the participation of the 5 TDS, and community interests can consult, discuss and make recommendations on matters affecting the policing of the area. It is co-operative in nature, operates with the minimum of formality in accordance with guidelines. The committee identifies, raises awareness of, and finds solutions for issues impacting on or causing concerns for the local community. The JPC meet at least 4 times a year,

and on 2 of these occasions holds public meetings in various locations throughout County Wicklow.

**Work of the JPC:** The work of the JPC is strategic in nature. The committee must prepare a six year strategic plan and an end of year annual report for submission to the Policing Authority by the 31<sup>st</sup> of March each year. It must also prepare an annual work plan, hold public meetings and function as a committee.

The Wicklow County Council JPC 6 year Strategic Plan 2016 - 2021: The WCC JPC 6 year Strategic Plan was adopted by Wicklow County Council on the 3<sup>rd</sup> of October, 2016. It sets out strategic priorities and objectives which link to the relevant objectives of the Garda Annual Policing Plan operational in the Wicklow County Council Area under the following 4 strategic priorities:-

Strategic Priority 1 – Policing Communities
Strategic Priority 2 – Tackling Crime in Rural Areas
Strategic Priority 3 – Supply Reduction
Strategic Priority 4 – Communications

Establishment of Policing Plan Committees by Municipal District Area: Initially four working groups were set up to advance the objectives of the JPC and roll out the agreed above four key areas within the Plan. This structure was identified as a step to achieve successful implementation of the 6 year Strategic Plan. However following an end of year review by the steering committee of the work of the groups and the resources constraints across JPC Membership, Wicklow County Council, An Garda Siochana and community representatives, it was agreed that the structure required adaptation and realignment across municipal districts to complement and enhance work already taking place.

At JPC meeting held on Monday the 2<sup>nd</sup> of September, 2019 the JPC agreed that 5 Policing Plan Committees be set up by municipal district area. The municipal district area based committees replace the sub committees set up under the 4 thematic areas set out above and set out in the WCC JPC 6 Year Strategic Plan.

#### **Terms of Reference for the Policing Plan Committees (5 in number)**

- 1. Policing Plan Committees (PPCs) will operate on a municipal district area basis (Bray, Arklow, Greystones, Wicklow and Baltinglass)
- 2. Membership of the PPCs will consist :-
  - 1) Municipal District Elected Members
    - Wicklow County Council Joint Policing Committee Report Year Ended 31<sup>st</sup> December, 2022.

- 2) Members of the Oireachtas
- 3) Members of the PPN who are represented on the JPC
- 4) Superintendent for the District (or his/her nominee)
- 5) Municipal District Administrator
- 6) Municipal District Engineer
- 3. The Chair of the Municipal District will act as chair to the PPC
- 4. PPCs will be supported by members of An Garda Siochana i.e. the Superintendent for the municipal district (and/or his/her nominees) the Municipal District Manager, Municipal District Administrator and Municipal District Engineer
- 5. PPCs will meet quarterly and prior to the Municipal District Meetings
- 6. The work of the PPC will be informed by the objectives of the WCC JPC 6 Year Strategic Plan, 2016 2021 and the Garda Annual Policing Plan
- 7. Each PPC will organise its work into an Annual Work Plan, drawing from the objectives of the WCC JPC 6 Year Strategic Plan and the Garda Annual Policing Plan, identifying issues to concentrate on over a 12 month period.
- 8. While meetings of the JPC are open to the public and the media, PPCs are working committees and as such are not open to the public or the media to attend.
- 9. Progress on implementation to be monitored and reviewed and reported on to the JPC at its meetings.
- 10. PPCs will submit an end of year report to the JPC which will in turn feed into the end of year annual report submitted to the Policing Authority in accordance with An Garda Siochana Act, 2005 and operating guidelines issued by the Department of Justice and Equality.
- 11. PPCs will operate for a period of 12 months following which their status will be reviewed by the WCC JPC.

Meetings of the Policing Plan Committees: Each of the five PPCs held inaugural meetings in the months of October, November and December, 2019. Meetings continued during 2022. Issues discussed concentrated on:-

- Local issues of concern
- Information sharing
- Garda accommodation
- Provision of CCTV Kilcoole, Greystones, Blessington and Baltinglass and Bray
- Business Watch

#### ITEM 1

Summary of progress in implementing the JPCs work plan: The JPC Work Plan, 2019 is contained within the 6 Year Strategic Plan and set out hereunder within this report. During 2022 meetings took place at municipal district level between WCC and An Garda Siochana. ITEM2 – Highlight three key achievements of the JPC during the year and give reasons why these are considered to be significant

# 1. Joint Policing Committee meeting of Wicklow and Wexford Policing committees

The inaugural joint policing committee meeting of Wicklow and Wexford Policing Committees was held on the 14<sup>th</sup> December 2022 in Gorey, Co. Wexford. This was the first joint policing committee meeting held nationally and was an opportunity for both committees to:

- Discuss the Wicklow /Wexford joint division model.
- Highlight relevant policing issues for both areas.
- Identify any future co-operation opportunities.
- Receive an update on the cyber threat landscape.

The meeting was a success and it is proposed they become an annual event. The next meeting will be held in County Wicklow in Autumn 2023. These meetings are an addition to the quarterly Wicklow Joint Policing Committee meetings.

#### 2. Public Joint Policing Committee Meetings

2022 marked the return of in-person public Joint Policing Committee meetings. Two were held, the first on the 4<sup>th</sup> May in Newtownmountkennedy, the second on the 10<sup>th</sup> December in Bray. Both had good attendance and engagement from the public. The meetings provided an opportunity for the Gardaí to outline the specialist services provided in each area which included Roads Policing Unit, Forensic Collision Investigator, Community Policing Unit, Detective Unit, Scenes of Crime Unit, Immigration Unit, Victim Service Office, Juvenile Liaison Office, Criminal Intelligence Office, Family Liaison, Ethnic Liaison and Crime Prevention Officer.

The importance of community engagement was also noted including Bray Garda Open Day, Bray Air Show, Purple House Run - Greystones to Bray and Garda Centenary events. The public present welcomed the opportunity to engage with the Gardaí and Local Authority staff on matters relating to their policing area. They also paid tribute to the excellent service provided by Community Gardaí in both areas.

#### 3. CCTV for Blessington

Wicklow County Council has successfully completed the implementation of a community-based CCTV system for Blessington town. The new system will be fully operational from 1st February 2023. Funding for the project has been provided for by Wicklow County Council with an additional funding grant of €40,000 coming from the Department of Justice and Equality. The project was initiated through Blessington Town Team and Blessington and District Forum and has been progressed and manged by Baltinglass Municipal District. The new system will operate in partnership with the local Gardaí and will be used to assist in the general policing of the area. The CCTV system will also act as a deterrent for anti-social behaviour and public order offences. The system will assist the Gardaí in the identification of

offenders and assist as evidence in prosecutions. This project will keep our citizens safe and serve not only the needs of An Garda Síochána but also enhance the citizen safety experience from a Wicklow County Council perspective. The CCTV programme is part of a programme of development which will see Blessington town become a centre of recreation as well as a safe place to live, work and shop in.
